

- 1 At the locations indicated, amend the bill as follows:
- 2 #. page 4, line 17: delete "dependent".
- 3 1. Page 4, line 18: delete "18 unless any of the following applies:" and
substitute "26." unless the surviving ^{child} has insurance
that is offered through his or her employer
- 4 2. Page 4, line 19: delete lines 19 to 22.
- 5 3. Page 9, line 5: delete lines 5 to 13 and substitute:
- 6 "SECTION 14m. 66.0137 (5) (c) 3. of the statutes is repealed and recreated to
- 7 read:
- 8 66.0137 (5) (c) 3. An individual is not a dependent child for the purposes of
- 9 subd. 1. or 1m. after the individual reaches the age of 26."
