


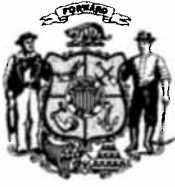

1 AN ACT ~~to repeal~~ 118.045 and 118.38 (1) (a) 8.; and **to amend** 119.04 (1) of the
2 statutes; **relating to:** the commencement of fall classes in public schools.

Analysis by the Legislative Reference Bureau

With certain exceptions, current law prohibits a school district from beginning fall classes until September 1. Beginning in the 2014-15 school year, this bill eliminates this prohibition.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

3 SECTION 1. 118.045 of the statutes is repealed. ✓

4 SECTION 2. 118.38 (1) (a) 8. of the statutes is repealed. ✓

5 SECTION 3. 119.04 (1) of the statutes is amended to read: ✓
