### Analysis by the Legislative Reference Bureau

This bill requires the Department of Workforce Development (DWD), when issuing a determination under certain employment laws administered by DWD, or a determination about eligibility for benefits under the unemployment insurance (UI) laws that is adverse to the interests of an employee, and when issuing a computation of UI benefits, to provide to the employee information about resources that may be available to assist the employee regarding the adverse determination or computation. The bill also requires DWD to maintain a telephone number so that such an employee who is adversely affected by a determination or computation may call DWD to ask questions about the determination or computation.


