

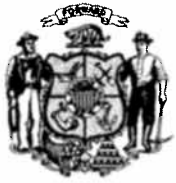
Aaron,

I'd like to put in a request to have a simple amendment drafted to SB 279 dealing with the phrase "vehicles that exceeds length or weight limitations under this chapter but does not violate length or weight limitations under Michigan law" (pg 2, line 6.) The amendment would limit the allowable weight to 164,000 lbs., regardless if Michigan approves a higher allowable weight limit.

1 At the locations indicated, amend the bill as follows:  
2 **1.** Page 3, line 25: after that line insert:  
3 “SECTION 6m. 348.27 (9) (d) of the statutes is created to read:  
4 348.27 (9) (d) A permit issued under this subsection does not authorize the  
5 operation of any vehicle or vehicle combination at a maximum gross weight in excess  
6 of 164,000 pounds.”.
