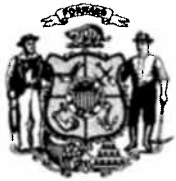

TO SENATE BILL 307

1 At the locations indicated, amend the bill as follows:

2 1. Page 18, line 15: delete lines 15 to 17 and substitute:

3 "SECTION 36m. Effective dates. This act takes effect on the 2nd day after
4 publication of the 2015-17 biennial budget act, except as follows:

5 (1) The treatment of sections 38.04 (4) (e) 7., 115.28 (11) (g), and 343.71 (5) (g)
6 of the statutes takes effect on the first day of the 4th month beginning after
7 publication."
