1. Amendment 1: An underutilized school building does not include a building that is being used for early childhood programs. Is there a way to appropriate define "early childhood programs?"
LRB a 0978
2. Amendment 2: Delete Page 5 lines 22-24, Page 6 lines 1-10. The goal is to allow any interested party the opportunity to purchase the building.
LRB a 0977
- ✓ 3. Amendment 3: Delete Page 6 lines 23-24 and any other language related to square footage/40% threshold.
LRB a 0976
- ✓ 4. Amendment 4: Delete all reference to 48 consecutive months. (We may need to provide more detail).
LRB a 0975
- ✓ 5. Amendment 5: p. 6, line 18, delete 12 months and replace with 28. The 28 months refers to the at least 2 year period it takes to appropriately plan for an reopen a school.
LRB a 0974
- ✓ 6. Amendment 6: p.6 Delete line 19 and 20. Eliminates references to the 12 months preceding the effective date of the bill. Putting in retroactive language is not fair when the district has clearly articulated that it has plans to reopen a number of buildings of the next two years.
