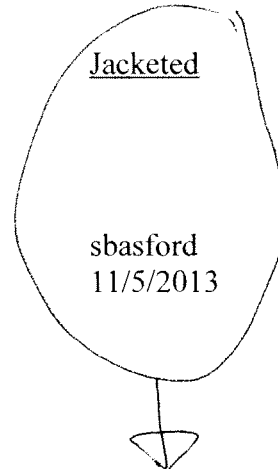

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 4, line 5: after that line insert:
- 3 **SECTION 6m.** 108.02 (12) (a) of the statutes is amended to read:
- 4 108.02 (12) (a) "Employee" means any individual who is or has been performing
- 5 services for pay for an employing unit, whether or not the individual is paid directly
- 6 by the employing unit, except as provided in par. (bm), (c), (d), (dm) or (dn), or (dp).
- 7 **SECTION 6p.** 108.02 (12) (a) of the statutes, as affected by 2013 Wisconsin Act
- 8 ... (this act), is amended to read:
- 9 108.02 (12) (a) "Employee" means any individual who is or has been performing
- 10 services for pay for an employing unit, whether or not the individual is paid directly
- 11 by the employing unit, except as provided in par. (bm), (c), (d), (dm), or (dn), or (dp).
- 12 **2.** Page 9, line 1: delete "stipend of \$75 per week" and substitute "weekly
- 13 stipend".
