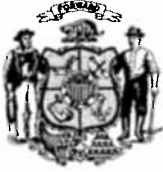
Robin,

Rep. Czaja and Sen. Gudex would like to request a simple amendment to AB 407/SB 343 (Irb 2493) that accomplishes the following:

- 1) Raise the non-resident trail pass fee to \$50/yr. (rather than \$45 as it is currently written)
- 2) Create a \$5 penalty for trail passes purchased after December 1 of the year/season
- 3) Change the definition of Vintage Sleds that will be exempted to 30 years or older (rather than the 25 yr definition as it currently written)
