- 5 **4.** Page 2, line 10: delete “940.32, 942.08, 942.09” and substitute “940.302,
- 6 involving a commercial sex act”.
- 7 **5.** Page 3, line 22: delete “act of domestic abuse,”.
- 8 **6.** Page 3, line 23: delete that line and substitute “violation”.
- 9 **7.** Page 3, line 24: delete “940.32, 942.08, 942.09” and substitute “940.302,
- 10 involving a commercial sex act”.
