- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 1, line 2: delete the material beginning with "certain animals" and
- 3 ending with "size" on line 3 and substitute "the unlawful taking of certain deer".
- 4 **2.** Page 2, line 8: delete "or elk and the skull of a bear".
- 5 **3.** Page 2, line 14: delete "the following wild animals" and substitute "deer
- 6 with antlers of the following sizes".
- 7 **4.** Page 2, line 20: delete lines 20 to 22.
