

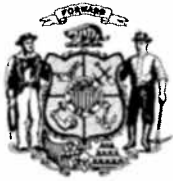
To address MFL:

On page 10 line 13, after “attorney” add: “, or to any document prepared pursuant to subchs. I and VI of Chapter 77”

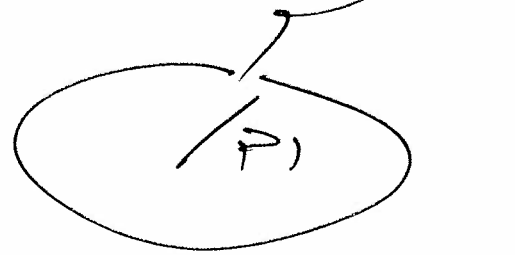

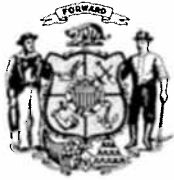
