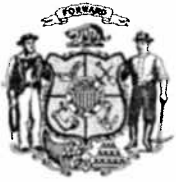
Mike,

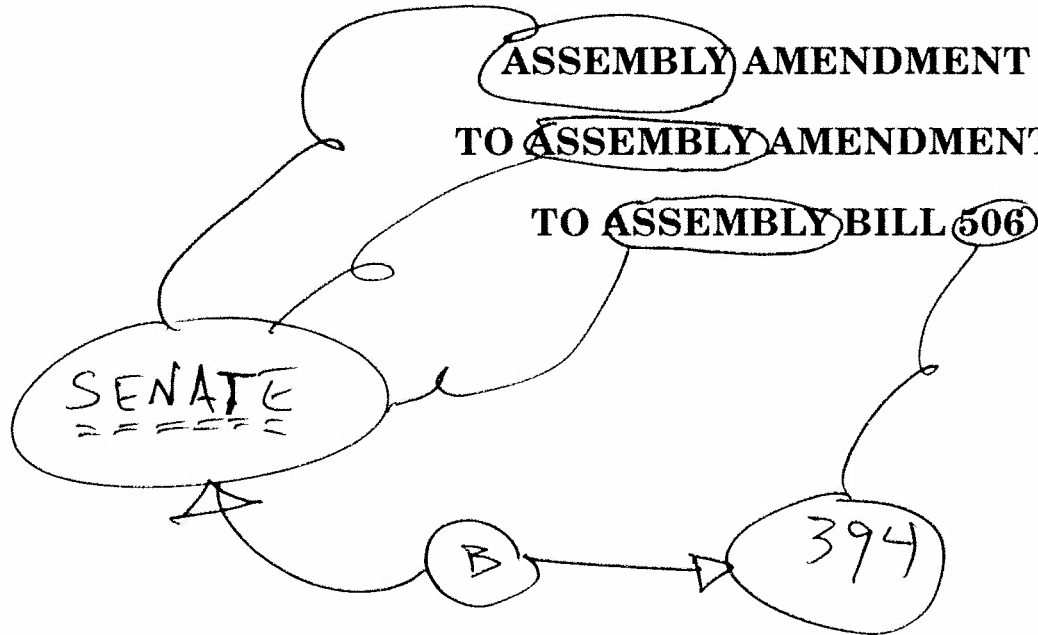
