- 1 At the locations indicated, amend the substitute amendment as follows:
- 2 **1.** Page 2, line 9: delete “paragraph, “telehealth”” and substitute “paragraph:”.
- 3 **2.** Page 2, line 9: before “is a” insert:
- 4 “a. “Mental health service” means a service that is covered under one of the
- 5 Medical Assistance mental health or substance abuse benefits under s. 49.46 (2) of
- 6 outpatient mental health, outpatient substance abuse, pharmacologic management,
- 7 mental health day treatment, substance abuse day treatment, crisis intervention,
- 8 service provided by a community support program or community based-psychosocial
- 9 service program, community recovery services, psychotherapy and alcohol and other
- 10 drug abuse services, child or adolescent day treatment services, or any other mental
- 11 health or substance abuse benefit described in s. 49.46 (2).
- 12 b. “Telehealth”.

1 **3.** Page 3, line 4: after “state” insert “and is an agency that is certified by the
2 department as an emergency mental health service program, a comprehensive
3 community services program, a mental health day treatment services program for
4 children, a program organized under s. 46.23, 51.42, or 51.437, an outpatient
5 psychotherapy clinic, or a community support program or that is certified by the
6 department to perform a community substance abuse prevention and treatment
7 service, except for narcotic treatment service for opiate addiction”.

8 **4.** Page 3, line 4: after that line insert:

9 “ag. The provider and the individual providing the service comply with all
10 Medical Assistance coverage policies and standards established by the department,
11 rules, and federal statutes and regulations for each particular mental health service
12 provided.

13 ar. The provider is certified for telehealth by the department.”.

14 **5.** Page 3, line 5: delete “provider” and substitute “individual who is providing
15 the service”.

16 **6.** Page 3, line 6: after “state” insert “and is in good standing with the
17 applicable examining board in this state for that individual’s profession”.
