

3 subd. 2., if”.

4 **2.** Page 2, line 11: after that line insert:

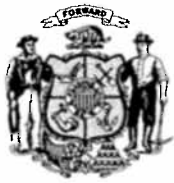
5 “2. School employees are not required to report the pupil’s use of the
6 epinephrine auto-injector under subd. 1. if any of the following applies:

7 a. A health care provider *physician or emergency medical technician* observes the pupil after the pupil uses the
8 epinephrine auto-injector and determines that it is not necessary to call “911” or, if
9 applicable, the telephone number for an emergency medical service provider.

10 b. A school employee knows that a person other than a school employee
11 reported the pupil’s use of the epinephrine auto-injector by calling “911” or, if

1 applicable, the telephone number for an emergency medical service provider, or
2 otherwise contacted the next appropriate level of emergency care.”.

8 pupil uses the epinephrine auto-injector and determines that it is not necessary to
9 call "911" or, if applicable, the telephone number for an emergency medical service
10 provider.

11 b. A school employee knows that a person other than a school employee
12 reported the pupil's use of the epinephrine auto-injector by calling "911" or, if

1 applicable, the telephone number for an emergency medical service provider, or
2 otherwise contacted the next appropriate level of emergency care.”.
