



## 2013 SENATE BILL 427

December 10, 2013 – Introduced by LAW REVISION COMMITTEE. Referred to  
Committee on Judiciary and Labor.

1     **AN ACT relating to:** affecting various provisions of the statutes to make  
2             corrections and reconcile conflicts (Corrections Bill).

*Analysis by the Legislative Reference Bureau*

This correction bill was prepared by the Legislative Reference Bureau under s.  
13.92 (1) (bm) 1. and 2. and (2) (i) and (L), stats. Specific changes are explained in  
the NOTES in the body of the bill.

*The people of the state of Wisconsin, represented in senate and assembly, do  
enact as follows:*

3             **SECTION 1.** 5.05 (10) of the statutes is amended to read:  
4             5.05 (10) STATE ELECTION ADMINISTRATION PLAN. With the assistance of the  
5             election administration council and approval of the joint committee on finance as  
6             provided in this subsection, the board shall adopt and modify as necessary a state  
7             plan that meets the requirements of P.L. 107-252 to enable participation by this  
8             state in federal financial assistance programs authorized under that law. The board  
9             shall adopt the plan and any modifications only after publishing a class I 1 notice

1 under ch. 985 or posting on the Internet a statement describing the proposed plan  
2 or modification and receiving public comment thereon. After approval of the  
3 proposed plan or any modification of the plan by the board, the board shall submit  
4 the proposed plan or modification to the joint committee on finance for the approval  
5 of the committee. The board may adopt the proposed plan or modification only if the  
6 committee approves the proposed plan or modification.

NOTE: Conforms text to ch. 985.

7 **SECTION 2.** 6.45 (1) of the statutes is amended to read:

8 6.45 (1) After the deadline for revision of the registration list, the municipal  
9 clerk shall make copies of the list for election use. ~~The registration list and any~~  
10 ~~supplemental lists which are prepared at polling places or other registration~~  
11 ~~locations under s. 6.55, shall be open to public inspection. Under the regulations~~  
12 ~~prescribed by the municipal clerk, any person may copy the registration list at the~~  
13 ~~office of the clerk. A registration list maintained at a polling place may be examined~~  
14 ~~by any person who is observing the proceedings under s. 7.41 when such use does not~~  
15 ~~interfere with the conduct of the election.~~

16 **SECTION 3.** 11.06 (1) (jm) of the statutes, as affected by 2011 Wisconsin Act 32,  
17 is amended to read:

18 11.06 (1) (jm) A copy of any separate schedule prepared or received pursuant  
19 to an escrow agreement under s. 11.16 (5). A candidate or personal campaign  
20 committee receiving contributions under such an agreement and attaching a  
21 separate schedule under this paragraph may indicate the percentage of the total  
22 contributions received, and disbursements made without itemization, except that

1 amounts received from any contributor pursuant to the agreement who makes any  
2 separate contribution to the candidate or personal campaign committee during the  
3 calendar year of receipt as indicated in the schedule shall be aggregated and itemized  
4 if required under par. (a) or (b).

NOTE: Removes comma and adds “and” for correct grammar.

5 **SECTION 4.** 13.94 (4) (a) 1. of the statutes, as affected by 2011 Wisconsin Act 10,  
6 is amended to read:

7 13.94 (4) (a) 1. Every state department, board, examining board, affiliated  
8 credentialing board, commission, independent agency, council or office in the  
9 executive branch of state government; all bodies created by the legislature in the  
10 legislative or judicial branch of state government; any public body corporate and  
11 politic created by the legislature including specifically the Fox River Navigational  
12 System Authority, the Lower Fox River Remediation Authority, the Wisconsin  
13 Aerospace Authority, and the Wisconsin Economic Development Corporation, a  
14 professional baseball park district, a local professional football stadium district, a  
15 local cultural arts district and a long-term care district under s. 46.2895; every  
16 Wisconsin works agency under subch. III of ch. 49; every provider of medical  
17 assistance under subch. IV of ch. 49; technical college district boards; every county  
18 department under s. 51.42 or 51.437; every nonprofit corporation or cooperative or  
19 unincorporated cooperative association to which moneys are specifically  
20 appropriated by state law; and every corporation, institution, association or other  
21 organization which receives more than 50% of its annual budget from appropriations  
22 made by state law, including subgrantee or subcontractor recipients of such funds.

1           **SECTION 5.** 15.145 (5) (intro.) of the statutes, as affected by 2011 Wisconsin Act  
2 32, is amended to read:

3           15.145 (5) COUNCIL ON OFFENDER REENTRY. (intro.) There is created a council on  
4 offender reentry which is attached to the department of corrections under s. 15.03,  
5 which shall have the duties, responsibilities, and powers set forth under s. 301.095.  
6 The council shall consist of ~~22~~ 21 members, and the appointed members shall serve  
7 for 2-year terms and may be appointed for a maximum of 2 consecutive terms. The  
8 chairperson of the council shall be the secretary of corrections or the reentry director,  
9 as decided by the secretary of corrections. The chairperson may appoint  
10 subcommittees and the council shall meet no less frequently than 4 times per year  
11 at a date and location to be determined by the chairperson. Members of the council  
12 shall include the secretary of corrections, or his or her designee; the secretary of  
13 workforce development, or his or her designee; the secretary of health services, or his  
14 or her designee; the secretary of children and families, or his or her designee; the  
15 secretary of transportation, or his or her designee; the attorney general, or his or her  
16 designee; the chairperson of the parole commission, or his or her designee; the state  
17 superintendent of public instruction; the reentry director as appointed by the  
18 secretary of corrections; a current or former judge, as appointed by the director of  
19 state courts; an individual who has been previously convicted of, and incarcerated  
20 for, a crime in Wisconsin, as appointed by the secretary of corrections; and the  
21 following persons, as appointed by the governor:

NOTE: 2011 Wis. Act 32 eliminated one of the members of the council without  
changing the number of members.

22           **SECTION 6.** 16.301 (intro.) of the statutes, as affected by 2011 Wisconsin Act 32,  
23 section 3450m, is amended to read:

1           **16.301 Definitions.** (intro.) In ~~this subchapter~~ ss. 16.301 to 16.315:

5 may not purchase that type of energy consuming equipment unless the specifications  
6 for the equipment meet the applicable standards. If there is an applicable standard  
7 under s. 16.855 (10s) (a), but the energy consuming equipment meeting that  
8 standard is not reasonably available, the department, purchasing agent, agency, or  
9 authority shall ensure, for purchases over \$5,000 per unit, that the energy  
10 consuming equipment that is purchased maximizes energy efficiency to the extent  
11 technically and economically feasible. The department, purchasing agent, agency,  
12 or authority shall not determine that energy consuming equipment that meets the  
13 applicable standard under s. 16.855 (10s) (a) either is not reasonably available on the  
14 basis of cost alone or is not cost-effective unless the difference in the cost of the  
15 purchase and installation of the equipment that meets the standard and the  
16 equipment that would otherwise be installed is greater than the difference in the cost  
17 of operating the equipment that meets the standard and the equipment that would  
18 otherwise be installed over the anticipated life of the equipment.

19           **SECTION 12.** 16.85 (1) of the statutes, as affected by 2011 Wisconsin Act 32,  
20 section 267, is amended to read:

21           16.85 (1) To take charge of and supervise all engineering or architectural  
22 services or construction work, as defined in s. 16.87 (1) (a), performed by, or for, the  
23 state, or any department, board, institution, commission, or officer of the state,  
24 including nonprofit-sharing corporations organized for the purpose of assisting the

2 additions to existing buildings as contemplated under ss. 13.488, 36.09, and 36.11,  
3 except work to be performed for the University of Wisconsin System with respect to

5 entirely with the proceeds of gifts or grants made to the system, and except the  
6 engineering, architectural, and construction work of the department of  
7 transportation; and the engineering service performed by the department of safety  
8 and professional services, department of revenue, public service commission,  
9 department of health services, and other departments, boards, and commissions  
10 when the service is not related to the maintenance, and construction and planning,  
11 of the physical properties of the state.

12 **SECTION 13.** 16.854 (2) (intro.) of the statutes is amended to read:

13 16.854 (2) (intro.) Subject to the requirements of s. 16.82 (7), the department  
14 may, upon request of any local professional baseball park district, if the district has  
15 entered into a lease agreement with the department under s. 16.82 (7), take charge  
16 of and supervise engineering or architectural services or construction work, as  
17 defined in s. 16.87 (1) (a), performed by, or for, the district for compensation to be  
18 agreed upon between the department and the district. In connection with such  
19 services or work, the department may furnish engineering, architectural, project  
20 management and other building construction services whenever requisitions  
21 therefor are presented to the department by the district. If the district has entered  
22 into a lease agreement with the department under s. 16.82 (7), the department may  
23 also assist the district, upon request of the district, in letting contracts for

1 engineering, architectural or construction work authorized by law and in  
2 supervising the work done thereunder. The department may award any such  
3 contract for any combination or division of work it designates and may consider any  
4 factors in awarding a contract including price, time for completion of work and the

6 this section for the construction of baseball park facilities, as defined in s. 229.65 (1),  
7 the department shall ensure that any person who is awarded a contract agrees, as  
8 a condition to receiving the contract, that his or her goal shall be to ensure that at  
9 least 25% of the employees hired because of the contract will be minority group  
10 members and at least 5% of the employees hired because of the contract will be  
11 women. It shall also be a goal of the department to ensure that at least 25% of the  
12 aggregate dollar value of contracts awarded for the construction of such facilities in  
13 the following areas are awarded to minority businesses and at least 5% of the  
14 aggregate dollar value of contracts awarded for the construction of such facilities in  
15 the following areas are awarded to women's businesses:

16 **SECTION 14.** 20.505 (1) (gr) of the statutes, as affected by 2011 Wisconsin Act  
17 32, section 406, is amended to read:

18 20.505 (1) (gr) *Disabled veteran-owned, woman-owned, and minority business*  
19 *certification fees.* All moneys received from fees collected under s. 16.283 (3) (c) for  
20 the costs of certifying disabled veteran-owned businesses under s. 16.283; all  
21 moneys received from fees collected under s. 16.285 (1) (bm), for the costs of certifying  
22 woman-owned businesses under s. ~~6.285~~ 16.285; and all moneys received from fees

1 collected under s. 16.287 (2) (dm) for the costs of certifying minority businesses under  
2 s. 16.287.

NOTE: Corrects cross-reference. 2011 Wis. Act 32 renumbered s. 560.035 to s. 16.285, but the cross-reference in this provision was changed from s. 560.035 (1) to s. 6.285. There is no s. 6.285.

3 **SECTION 15.** The treatment of 20.923 (8) of the statutes by 2011 Wisconsin Act  
4 10 is not repealed by 2011 Wisconsin Act 32. Both treatments stand.

NOTE: There is no conflict of substance. As merged by the legislative reference bureau, s. 20.923 (8) reads:

(8) DEPUTIES. Salaries for deputies appointed pursuant to ss. 13.94 (3) (b), 15.04 (2), 230.04 (16), and 551.601 (1) shall be set by the appointing authority. The salary shall not exceed the maximum of the salary range one range below the salary range of the executive salary group to which the department or agency head is assigned. The positions of assistant secretary of state, assistant state treasurer and associate director of the historical society shall be treated as unclassified deputies for pay purposes under this subsection. The salary of the deputy director of the office of business development in the department of administration is assigned to executive salary group 2.

5 **SECTION 16.** 23.0917 (6m) (d) of the statutes is amended to read:

8 **SECTION 17.** 25.49 (intro.) and (1) of the statutes, as affected by 2011 Wisconsin  
9 Act 32, are consolidated, renumbered 25.49 and amended to read:

10 **25.49 Economic development fund.** There is established a separate  
11 nonlapsible trust fund designated as the economic development fund, to consist of:  
12 ~~(1) The~~ the surcharge imposed under subch. VII of ch. 77.

NOTE: Section 25.49 does not have multiple subsections.

13 **SECTION 18.** The treatment of 36.09 (1) (j) of the statutes by 2011 Wisconsin Act  
14 10 is not repealed by 2011 Wisconsin Act 32. Both treatments stand.

NOTE: There is no conflict of substance. As merged by the legislative reference bureau, effective 7-1-15, s. 36.09 (1) (j) reads:

(j) Except where such matters are a subject of bargaining with a certified representative of a collective bargaining unit under s. 111.91, the board shall establish salaries for persons prior to July 1 of each year for the next fiscal year, and shall designate

the effective dates for payment of the new salaries. In the first year of the biennium, payments of the salaries established for the preceding year shall be continued until the biennial budget bill is enacted. If the budget is enacted after July 1, payments shall be made following enactment of the budget to satisfy the obligations incurred on the effective dates, as designated by the board, for the new salaries, subject only to the appropriation of funds by the legislature and s. 20.928 (3). This paragraph does not limit the authority of the board to establish salaries for new appointments. The board may not increase the salaries of employees under this paragraph unless the salary increase conforms to the proposal as approved under s. 230.12 (3) (e) or the board authorizes the salary increase to correct salary inequities under par. (h), to fund job reclassifications or promotions, or to recognize competitive factors. The granting of salary increases to recognize competitive factors does not obligate inclusion of the annualized amount of the increases in the appropriations under s. 20.285 (1) for subsequent fiscal bienniums. NOTE: There is no conflict of substance. As merged by the legislative reference bureau, s. 40.05 (4) (b) reads:

(b) Except as provided under pars. (bc) and (bp), accumulated unused sick leave under ss. 13.121 (4), 36.30, 230.35 (2), 233.10, 238.04 (8), and 757.02 (5) and subch. V of ch. 111 of any eligible employee shall, at the time of death, upon qualifying for an immediate annuity or for a lump sum payment under s. 40.25 (1) or upon termination of creditable service and qualifying as an eligible employee under s. 40.02 (25) (b) 6. or 10., be converted, at the employee's highest basic pay rate he or she received while employed by the state, to credits for payment of health insurance premiums on behalf of the employee or the employee's surviving insured dependents. Any supplemental compensation that is paid to a state employee who is classified under the state classified civil service as a teacher, teacher supervisor, or education director for the employee's completion of educational courses that have been approved by the employee's employer is considered as part of the employee's basic pay for purposes of this paragraph. The full premium for any eligible employee who is insured at the time of retirement, or for the surviving insured dependents of an eligible employee who is deceased, shall be deducted from the credits until the credits are exhausted and paid from the account under s. 40.04 (10), and then deducted from annuity payments, if the annuity is sufficient. The department shall provide for the direct payment of premiums by the insured to the insurer if the premium to be withheld exceeds the annuity payment. Upon conversion of an employee's unused sick leave to credits under this paragraph or par. (bf), the employee or, if the employee is deceased, the employee's surviving insured dependents may initiate deductions from those credits or may elect to delay initiation of deductions from those credits, but only if the employee or surviving insured dependents are covered by a comparable health insurance plan or policy during the period beginning on the date of the conversion and ending on the date on which the employee or surviving insured dependents later elect to initiate deductions from those credits. If an employee or an employee's surviving insured dependents elect to delay initiation of deductions from those credits, an employee or the employee's surviving insured dependents may only later elect to initiate deductions from those credits during the annual enrollment period under par. (be). A health insurance plan or policy is considered comparable if it provides

1           **SECTION 20.** The treatment of 40.05 (5) (b) 4. of the statutes by 2011 Wisconsin  
2 Act 10 is not repealed by 2011 Wisconsin Act 32. Both treatments stand.

NOTE: There is no conflict of substance. As merged by the legislative reference bureau, s. 40.05 (5) (b) 4. reads:

4. The accrual and crediting of sick leave shall be determined in accordance with ss. 13.121 (4), 36.30, 230.35 (2), 233.10, 238.04 (8), and 757.02 (5) and subch. V of ch. 111.

3           **SECTION 21.** The treatment of 40.62 (2) of the statutes by 2011 Wisconsin Act  
4 10 is not repealed by 2011 Wisconsin Act 32. Both treatments stand.

NOTE: There is no conflict of substance. As merged by the legislative reference bureau, s. 40.62 (2) reads:

(2) Sick leave accumulation shall be determined in accordance with rules of the department, any collective bargaining agreement under subch. V of ch. 111, and ss. 13.121 (4), 36.30, 49.825 (4) (d) and (5) (d), 49.826 (4) (d), 230.35 (2), 233.10, 238.04 (8), 757.02 (5) and 978.12 (3).

5           **SECTION 22.** 41.57 (5) (title) of the statutes, as affected by 2011 Wisconsin Act  
6 32, is repealed.

NOTE: See the next section of this bill.

7           **SECTION 23.** 41.57 (5) (intro.), (c) and (d) of the statutes, as affected by 2011  
8 Wisconsin Act 32, sections 1224, 1227 and 1228, are renumbered 41.57 (intro.), (1)  
9 and (2).

NOTE: Section 41.57, as affected by 2011 Wis. Act 32, does not have multiple subsections and sub. (5) does not have paragraphs (a) and (b). See also SECTION 76 and the previous section of this bill.

10           **SECTION 24.** 62.50 (13) of the statutes is amended to read:

11           62.50 (13) NOTICE OF DISCHARGE OR SUSPENSION; APPEALS. The chief discharging  
12 or suspending for a period exceeding 5 days any member of the force shall give  
13 written notice of the discharge or suspension to the member and, at the same time  
14 that the notice is given, and shall also give the member any exculpatory evidence in  
15 the chief's possession related to the discharge or suspension. The chief shall also  
16 immediately report the notice of the discharge or suspension to the secretary of the

1 board of fire and police commissioners together with a complaint setting forth the  
2 reasons for the discharge or suspension and the name of the complainant if other  
3 than the chief. Within 10 days after the date of service of the notice of a discharge

6 commissioners, by filing with the board a notice of appeal in the following or similar

12 **SECTION 25.** 66.0506 (1) of the statutes, as affected by 2011 Wisconsin Act 32,  
13 is amended to read:

14 66.0506 (1) In this section, “local governmental unit” means any city, village,  
15 town, county, metropolitan sewerage district, long-term care district, ~~transit~~  
16 ~~authority under s. 59.58 (7) or 66.1039~~, local cultural arts district under subch. V of  
17 ch. 229, or any other political subdivision of the state, or instrumentality of one or  
18 more political subdivisions of the state.

NOTE: Sections 59.58 (7) and 66.1039 were repealed by 2011 Wis. Act 32.

19 **SECTION 26.** 71.28 (1dm) (k) of the statutes, as affected by 2011 Wisconsin Act  
20 32, is amended to read:

21 71.28 (1dm) (k) If a person who is entitled under s. 238.395 (3) (a) 4. or s.  
22 560.795 (3) (a) 4., 2009 stats., to claim tax benefits or certified under s. 238.395 (5),  
23 ~~239.398~~ 238.398 (3), or 238.3995 (4) or s. 560.795 (5), 2009 stats., s. 560.798 (3), 2009

1 stats., or s. 560.7995 (4), 2009 stats., ceases business operations in the development
