Attached are the two amendments you should have drafted and introduced with the senate version of AB 581.

LRB 1534 makes a few technical changes. It gives a definition for internet account, one that matches the definitions used in recent legislation passed in the assembly. It amends the bill to say "petition and notice" where petition or notice are referenced. It requires the court to take into consideration the state and/or federal Indian child welfare acts when appropriate. It provides a definition for relative, by referencing the most common definition used in chapter 48.

LRB 1524 makes the bill more uniform. As amended, the bill will now say that if you plan to delegate your parental powers to a relative you do not need to get the courts approval.
