**SENATE AMENDMENT ,  
TO SENATE BILL 462**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 4: after “premises” insert “, possession or consumption of alcohol  
3 beverages on school premises or at school-sponsored activities,”.

4 **2.** Page 2, line 3: after that line insert:

5 “SECTION 1m. 125.09 (2) (b) (intro.) of the statutes is amended to read:

6 125.09 (2) (b) (intro.) Except as provided by ~~par.~~ pars. (c) and (cr), no person may  
7 possess or consume alcohol beverages:”.

8 **3.** Page 2, line 11: delete “No” and substitute “Except as provided in par. (cr),  
9 no”.
