On page 2, line 6, insert ", except to report an emergency".

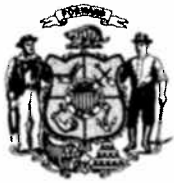
SECTION 1. 346.89 (5) of the statutes is created to read:

346.89 (5) No person may drive, as defined in s. 343.305 (1) (b), any motor vehicle while using a cellular or other wireless telephone, including using the telephone for a purpose other than communication, where persons engaged in work in a highway maintenance or construction area or in a utility work area are at risk from traffic, unless the driver uses the telephone without the use of his or her hands, **except to report an emergency.**
