Good afternoon,

I'd like to request an expedited amendment to SB 479 (LRB-1462/1) regarding the use of cellphones in work zones.

On page 2, line 6, insert ", except to report an emergency".

SECTION 1. 346.89 (5) of the statutes is created to read:

346.89 (5) No person may drive, as defined in s. 343.305 (1) (b), any motor vehicle while using a cellular or other wireless telephone, including using the telephone for a purpose other than communication, where persons engaged in work in a highway maintenance or construction area or in a utility work area are at risk from traffic, unless the driver uses the telephone without the use of his or her hands, except to report an emergency.


