

## **2013 BILL**

AN ACT/to repeal 16.40 (24) and 20.505 (1) (fz); and to create 16.40 (24) and 20.505 (1) (fz) of the statutes; relating to: a grant to the city of Milwaukee to support the HOME GR/OWN program and making an appropriation.

#### Analysis by the Legislative Reference Bureau

This bill makes a grant from general purpose revenues to the city of Milwaukee in the amount of \$2,000,000 for the purpose of supporting the city's HOME GR/OWN program to transform foreclosed properties into community assets that improve health and spark economic opportunity.

For further information see the **state** fiscal estimate, which will be printed as an appendix to this bill.

# The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

- **SECTION 1.** 16.40 (24) of the statutes is created to read:
- 16.40 (24) Grant to city of Milwaukee for HOME GR/OWN PROGRAM. From the appropriation under s. 20.505 (1) (fz), provide a grant in the amount of \$2,000,000 for the purpose of supporting the city of Milwaukee's HOME GR/OWN program to

act), is repealed.

under s. 16.40 (24) to carry out the HOME GR/OWN program.
Section 5. 20.505 (1) (fz) of the statutes, as created by 2013 Wisconsin Act
(this act), is repealed.
SECTION 6. Effective dates. This act takes effect on the day after publication,
except as follows:
(1) The repeal of sections 16.40 (24) and 20.505 (1) (fz) of the statutes takes
effect on July 1, 2015.
