

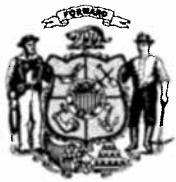

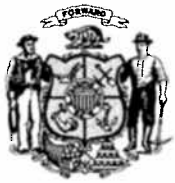

3 “(1g) TREATMENT ALTERNATIVE AND DIVERSION PROGRAM; ADMINISTRATIVE  
4 RESOURCES. In the schedule under section 20.005 (3) of the statutes for the  
5 appropriation to the department of justice under section 20.455 (2) (a) of the statutes,  
6 as affected by the acts of 2013, the dollar amount is increased by \$366,000<sup>for</sup> the second  
7 fiscal year of the fiscal biennium in which this subsection takes effect to increase the  
8 authorized FTE positions for the department of justice by 5.0 GPR positions and to  
9 provide administrative resources for counties that establish alternatives for  
10 prosecution and incarceration.”.
