

Hi, Mary,

In light of some concerns that have come to our attention since the Assembly labor committee held an executive session on AB 683, Representative Larson would like another amendment that does the following to 101.862(6) (Section 16):

1. Revises 101.862(6)(a) to include two-family dwellings as well as single-family dwellings. I don't know whether it would easier or more correct to just have it read "one- or two-family dwelling" or to simply say "...new dwelling, as defined by 101.61(1)".
2. Removes 101.862(6)(b)3.

Please let me know if you have any questions or concerns. The Assembly plans to take up AB 683 on Tuesday, and it is my understanding that the Senate may also be taking up SB 545 that day. If Senator Grothman's staff asks you to draft an identical amendment, please do so.
