

#### Amendments on SB-592

~~The first one just increases the limit of liability to \$1 million~~

1. ~~On line page 2, line 5, delete "\$300,000" and insert "\$1,000,000"~~

**This second would create a separate subsection under the statute that allows parents to opt out of the current law, but then requires parents or adult sponsor to purchase \$300,000 in insurance for one occurrence and require the parents or adult sponsor to keep the minor child on any household liability policy.**

2. On page 2, line 4, add the following sentence after "misconduct." Create (b) Parents or adult sponsors who want to limit their liability for sponsorship for a person under age 18 years of age, must purchase liability insurance in the sum \$300,000 for any one occurrence under the policy. Parents or the adult sponsors are required to retain a person under 18 years of age who is a license driver as a member of the household on any liability insurance policy purchased.

2 1. Page 2, line 4: delete the material beginning with "The" and ending with  
3 "accident." on line 6 and substitute "A parent or adult sponsor<sup>s</sup> who wishes to limit his  
4 or her liability under this paragraph shall maintain motor vehicle liability insurance  
5 that provides coverage in the amount of at least \$300,000 for bodily injury or death  
6 in any one accident and that provides coverage for each person under 18 years of age  
7 who is a licensed driver and a member of the primary insured's household."

8 2. Page 2, line 7: delete lines 7 to 9.
