

Jen- Here are the changes we are planning to make tomorrow to the WHEDA bill:

- Base eligibility on median family income, as the fiscal bureau paper and initial drafts are written, compared to household income which is in the bill currently. It is our understanding that family income is more commonly used in the housing sphere and will reach slightly higher income levels.
- Remove any reference to a possible two years of subsidy payments. This will codify the one-time nature of the subsidy for each loan. Under the bill as introduced, WHEDA could limit the subsidy to one-time, but this amendment would establish the payment as one-time by statute. This was recommended by WHEDA and fiscal bureau said it would help clean up the bill.
