

Bob,

Per our conversation, I'd like to request an amendment to SB 613 (LRB-3436) and AB 805 (LRB-4283) to do the following:

- Sunset the provisions of Sections 1 and 7
 - o No further funds are to be appropriated for s. 45.46 after June 30, 2015
 - o No funds may be expended by the department for the purpose of making grants to nonprofit organizations after June 30, 2015.

It may be easier to repeal Sections 1 and 7, and instead include non-statutory provisions to accomplish the above. Call me if you'd like to discuss this option.

Representative Petryk is the author of the Assembly companion and will need a version of the amendment as well. His staff, Marcie Rainbolt, is copied to this message if you have any questions on permission.

**SENATE AMENDMENT ,
TO SENATE BILL 613**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 2, line 9: ✓ after that line insert:

3 "SECTION 1g. 20.485 (2) (tf) of the statutes, as affected by 2013 Wisconsin Act

4 (circled)(this act), is repealed and recreated to read:
A

5 20.485 (2) (tf) *Veterans tuition reimbursement program*. Biennially, the
6 amounts in the schedule for the veterans tuition reimbursement program under s.
7 45.20 (2). Notwithstanding s. 20.001 (3) (a), the department may encumber moneys
8 under this appropriation for the biennium up to 60 days after the end of that
9 biennium if an estimate is first submitted to the department of administration
10 showing the amounts that will be encumbered during that 60-day period." ✓

2 act), is repealed." *created*

3 4. Page 4, line 13: after that line insert:

4 "SECTION 10g. Effective dates. This act takes effect on the day after
5 publication, except as follows:

6 (1) The repeal of section 45.46 of the statutes and the repeal and recreation of
7 section 20.485 (2) (tf) of the statutes takes effect on July 1, 2015."
