Per our conversation, I'd like to request an amendment to SB 613 (LRB-3436) and AB 805 (LRB-4283) to do the following:

- Sunset the provisions of Sections 1 and 7
  - o No further funds are to be appropriated for s. 45.46 after June 30, 2015
  - No funds may be expended by the department for the purpose of making grants to nonprofit organizations after June 30, 2015.

It may be easier to repeal Sections 1 and 7, and instead include non-statutory provisions to accomplish the above. Call me if you'd like to discuss this option.

# SENATE AMENDMENT, TO SENATE BILL 613

At the locations indicated, amend the bill as follows:

1. Page 2, line 9: after that line insert:

"Section 1g. 20.485 (2) (tf) of the statutes, as affected by 2013 Wisconsin Act ....(this act), is repealed and recreated to read:

20.485 (2) (tf) Veterans tuition reimbursement program. Biennially, the amounts in the schedule for the veterans tuition reimbursement program under s. 45.20 (2). Notwithstanding s. 20.001 (3) (a), the department may encumber moneys under this appropriation for the biennium up to 60 days after the end of that biennium if an estimate is first submitted to the department of administration showing the amounts that will be encumbered during that 60-day period.".
