Hi Gordon, Senator Risser would like amendments drafted to SB626 and AB750 that would exempt any employer (non-profit, for profit) that provide home, personal or nursing or other care to disabled, elderly or other vulnerable populations through county or city-county health departments.

The goal is to keep the provisions of the bills from affecting the living wage provisions for agencies that contract with Dane and Milwaukee County that provide this care to vulnerable populations. Dane County is not a Family Care county, Milwaukee County is.

There may be other amendments coming tomorrow or from Senator Harris's office.

5 disabilities, persons who are elderly, or other vulnerable populations through a  
6 county health department established under s. 251.02 (1) or a city-county health  
7 department established under s. 251.02 (1m)”.

8 **3.** Page 3, line 16: after “treasury” insert “, other than an employee who  
9 provides home care, personal care, nursing care, or other care to persons with  
10 disabilities, persons who are elderly, or other vulnerable populations through a  
11 county health department established under s. 251.02 (1) or a city-county health  
12 department established under s. 251.02 (1m)”.
