

Attached are drafting instructions for an Omnibus Accessibility bill draft requested by the Wisconsin Council for the Blind. I have not entered the request as I may not even be involved in any of the drafting, so the first step will be for someone to step up and act as coordinator for this project. The requester is Senator Schultz, and the person to contact is Gary Goyke at gary.goyke@gmail.com or at 219-5237.

The draft will consist of eight items, which I can flesh out a little bit further based on a conversation with representatives of the Council that I had yesterday. The eight items are as follows:

- Update the public accommodations law, s. 106.52 (1) (fm) and (3) (am) to bring those provisions into compliance with recent federal ADA changes made with respect to service animals. Apparently, the feds have tightened the definition of "service animal" so that it includes only dogs and small horses that are trained to help you and not your pet ferret who accompanies you everywhere. (MES)
- Similarly, update the open housing law, s. 106.50 (2r) (bm). (MES)
- Require DOT to submit a report to the legislature on the effectiveness of the white cane lane, s. 346.26, in improving pedestrian safety. Review the effectiveness of DOT's promotion, education, and enforcement efforts as well as the adequacy of the penalties for a violation. Make recommendations to improve that effectiveness. (ARG/EVM)
- Require the creation of a Legislative Council study committee to study the Business Enterprise Program under s. 47.03, that is, the program administered by the DVR in DWD under which persons who are visually impaired run food service and vending machine programs in state office buildings and highway rest areas, and to make recommendations for the continuation and enhancement of that program. (TJD)
- 5. Require DHS to submit a report to the legislature on the status of the Office of the Blind and Visually Impaired, s. 46.293. Is it meeting expectations? Recommendations to increase its effectiveness. (TJD)
- 6. Require DOA to submit a report to the legislature on access to state business loans and contracting for businesses run by people who are blind or visually impaired. Review the adequacy of current policies and make recommendations to improve that accessibility. (CMH—state contracts/ MPG/FFK—state business loans)
- 7. Require DSPS, in consultation with DOT, to submit a report to the legislature on large print and Braille signage in public buildings, s. 101.13, and on audio traffic signals so as to improve the ability of people who are blind or visually impaired to travel and otherwise find their way. (MGG/RNK—public buildings/ARG/EVM—audio traffic signals.
- 8. Require DPI, in consultation with the Office of the Blind and Visually Impaired in DHS, to submit a report to the legislature recommending ways and means to improve the adjustment program who persons who have recently gone blind. Section 115.525 (3) (c) 4. (PG/TKK/FFK—DPI/TJD—DHS).

So there you have it. Other than the substantive changes to ss. 106.50 and 106.52, the draft primarily involves directing agencies to submit reports to the legislature. If you have any questions, you can ask me, although about all I know is what is set forth above, or Gary Goyke at the e-mail address or cell phone number set forth above.
