We would like to request two amendments for AB14 which we'd like to get in time to meet the 9am priority amendment deadline tomorrow.

~~1. We would like to request that the bill be amended to allow for DWD to request the 2 additional staff members from the Joint Committee on Economic Development to administer their responsibilities, which the committee would be approving that time.~~

2. If DWD provides grant funding to a private company for the purpose of providing direct, in-house training; workers who complete the training must be employed in a full time job and earn at least \$20,000 in the coming year in a tier I county or municipality, and at least \$30,000 in a tier II county or municipality*.

*The tier I and II language comes from Commerce statutes governing the Jobs Tax Credit to define a family-supporting job.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 3, line 24: after "department." insert "As a condition of receiving a
- 3 grant under this subsection, the department shall require a private organization
- 4 that uses the grant moneys received for the training of its own employees to employ
- 5 any employee who completes the training as a full-time employee, as defined in s.
- 6 238.399 (1) (am) 1., and to pay that employee not less than \$20,000 per year in the
- 7 year following completion of the training, if the employee is employed in a tier 1
- 8 county or municipality, as defined by the Wisconsin Economic Development
- 9 Corporation under s. 238.399 (6) (g) 1., or not less than \$30,000 per year in the year
- 10 following completion of the training, if the employee is employed in a tier 2 county
- 11 or municipality, as so defined. "
