3 "SECTION 1d. 13.94 (1) (mv) of the statutes is created to read:

4 13.94 (1) (mv) No later than July 1, 2015, prepare a financial and performance  
5 audit of the workforce training program under s. 106.27. The legislative audit bureau  
6 shall file a copy or report of the audit under this paragraph with the distributees  
7 specified in par. (b).
