

We would like to request two amendments for AB14 which we'd like to get in time to meet the 9am priority amendment deadline tomorrow.

1. Rather than approving all 4 staff created at DWD as called for in the bill, we would like to approve 2 staff members. However, we would like to allow for DWD to request the 2 additional staff members from the Joint Committee on Finance if there is a need for additional staff to administer their responsibilities, which the committee could then approve at that time.

- 1 At the locations indicated, amend the bill as follows:
- 2 **1.** Page 3, line 7: delete “1,660,000 3,160,000” and substitute “1,442,500
- 3 2,942,600”.
- 4 **2.** Page 4, line 21: delete “4.0” and substitute “2.0”.
- 5 **3.** Page 4, line 24: after “act.” insert “If the department of workforce
- 6 development determines that additional positions are necessary for the
- 7 administration of that program, that department may request the joint committee
- 8 on finance under section 16.505 of the statutes to authorize not more than 2.0
- 9 additional GPR positions, to be funded from the appropriation under section 20.445
- 10 (1) (bm) of the statutes, as created by this act, for the purpose of administration of
- 11 that program.”.
