Hi Annika,

Here is the amendment that Senator Lehman had drafted that incorporates the labor provision from Senator Lassa's bill into Senator Farrow and Representative Brooks' bill. The UIAC (Unemployment Insurance Advisory Council-consisting of five representatives from labor and five from management) met last Thursday and voted to approve Senator Lassa's version of the work-share bill. It also said it would approve Senator Farrow and Representative Brooks' bill IF they amended it to incorporate the labor provision. As you probably know, the Legislature has a strong history of following the advice of the UIAC because its members are the experts who actually deal with the consequences of changes to UI.

Also as an fyi, both Senator Lassa's and the republicans' bills will need to be amended to incorporate some recommendations by the Department of Labor to ensure that Wisconsin would receive federal funding. That amendment has been sent back to DOL for its approval.
