ASSEMBLY AMENDMENT 2,
TO ASSEMBLY BILL 15

February 27, 2013 - Offered by Representative SHANKLAND.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 8, line 8: after that line insert:

3 “(km) Include a statement signed by the authorized agent of any representative
4 of the employees included in the work-share program to the effect that the
5 representative has approved the plan whenever approval is required under sub.
6 (13).”.

7 **2.** Page 10, line 16: after that line insert:

8 “(13) APPROVAL BY EMPLOYEE REPRESENTATIVE. If there is a single representative
9 representing some or all of the employees who are included in a work-share plan, the
10 plan is subject to approval of that representative.”.
