There are three more items.

Wondering if 0404 amendments from Rep. Pasch could be redrafted – still as a separate amendments - for the engrossed AB85?

Then I have a new request...

It is for the most part removing some of the County Executives new authority to introduce legislation and re-affirming that the county board is the single legislative branch.

So with that said. We are requesting one simple amendment that does all the following to the engrossed AB85 that includes the language from

- LRB 13a0403 (a0463)
- and then deletes from the engrossed bill...
- pg 11 line 6-7 “Any department head appointed by a county executive under this subsection may be removed at the pleasure of the county executive”
  - pg 21 line 12-13 “(c) The board may not create any county department or subunit of a department, except as provided in s. 59.17 (2) (b) 2.”
  - Pg 21 line 16 – 20 (e) The board may not terminate, lower the salary or benefits of, or eliminate the position of, any county employee who works in the office of the county executive unless a similar change is made which affects county employees, on a countywide basis, in all other county departments. This paragraph does not apply after the county board supervisors who are elected in the 2016 spring election take office.”

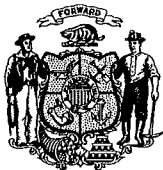
