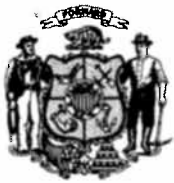

4 the council. If the secretary determines <sup>e</sup> ~~that~~ on the first day of any year <sup>all</sup> ~~that~~ the <sup>STET</sup>  
5 council has failed to meet at all during the previous year, <sup>e</sup> the council is dissolved."

**SENATE BILL 29****SECTION 1**

1           15.347 (9) OFF-ROAD VEHICLE COUNCIL. (a) There is created in the department  
2 of natural resources an off-road vehicle council consisting of 7 members appointed  
3 for 3-year terms expiring March 1.

4           (b) Each member of the off-road vehicle council shall be a resident of this state,  
5 shall be a member and represent the interests of an all-terrain vehicle or utility  
6 terrain vehicle user's group, and shall be knowledgeable about outdoor recreation  
7 issues in this state and about trails used by operators of all-terrain vehicles and  
8 utility terrain vehicles.

9           (c) The off-road vehicle council shall meet at least 3 times annually.

10          **SECTION 2.** 23.178 of the statutes is created to read:

11          **23.178 Off-road vehicle council.** The off-road vehicle council shall provide  
12 advice and make recommendations to the department of natural resources, the  
13 department of transportation, the governor, and the legislature on all matters  
14 relating to all-terrain vehicle trails and all-terrain vehicle routes, including matters  
15 relating to activities conducted on all-terrain vehicle trails and all-terrain vehicle  
16 routes by all-terrain vehicle users and utility terrain vehicle users, and shall make  
17 recommendations to the department of natural resources with regard to incentive  
18 payment requests under s. 23.33 (5r) and requests for funding under s. 23.33 (9) (b),  
19 (bg), and (c).

20          **SECTION 3. Nonstatutory provisions.**

21          (1) Notwithstanding the length of terms specified in section 15.347 (9) (a) of the  
22 statutes, as created by this act, the governor shall appoint the initial members of the  
23 off-road vehicle council for the following terms:

24           (a) Two members appointed under section 15.347 (9) of the statutes, as created  
25 by this act, for terms expiring on March 1, 2015.
