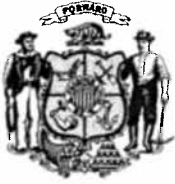

1 AN ACT to create 84.10315 of the statutes; relating to: designating and marking  
2 STH 128 as the 128th Infantry Memorial Highway.

### *Analysis by the Legislative Reference Bureau*

Under current law, certain highway routes and bridges have been designated and marked to memorialize, commemorate, or recognize certain individuals, groups, or events. This bill directs the Department of Transportation to designate and, upon receipt of sufficient contributions from interested parties, mark the route of STH 128 in Pierce and St. Croix counties as the "128th Infantry Memorial Highway" to honor the members of the 128th Battalion of the 32nd Infantry Brigade for bravery, sacrifice, and devotion in their service in Iraq as well as World Wars I and II. No state funds, other than from contributions from interested parties, may be used for the erection or maintenance of any markers to identify the highway as the "128th Infantry Memorial Highway."

For further information see the *state* fiscal estimate, which will be printed as an appendix to this bill.

*The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:*

3 SECTION 1. 84.10315 of the statutes is created to read:  
4 **84.10315 128th Infantry Memorial Highway.** (1) The department shall  
5 designate and, subject to sub. (2), mark the entire route of STH 128, commencing at
