TO SENATE BILL 72

April 24, 2013 – Offered by Senator ERPENBACH.

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 2: before “reports” insert “review of the one- and two-family”
3 dwelling code by the department and”.

4 **2.** Page 2, line 18: delete “once every 6” and substitute “at least once every 3”.

5 **3.** Page 2, line 19: after that line, insert: *delete the material inserted by Assembly Amendment 1 and substitute*
6 “SECTION ^(2p) ~~2m.~~ ^(B) 101.63 (5) of the statutes is amended to read:

7 101.63 (5) ~~Biennially review~~ Review the rules adopted under this subchapter

8 at least once every ~~three~~ years.”.
