

1 **(5) USE OF INFORMATION BY FINANCIAL INSTITUTION; PENALTY.** A financial
2 institution participating in the financial record matching program under this
3 section, and the employees, agents, officers, and directors of the financial institution,
4 may use information received from the department under sub. (3) only for the
5 purpose of matching records and may use information provided by the department
6 in requesting additional information under sub. (4) only for the purpose of providing
7 the additional information. Neither the financial institution nor any employee,
8 agent, officer, or director of the financial institution may disclose or retain
9 information received from the department concerning debtors. Any person who
10 violates this subsection may be fined not less than \$50 nor more than \$1,000 or
11 imprisoned in the county jail for not less than 10 days or more than one year or both.

12 **(6) USE OF INFORMATION BY DEPARTMENT.** The department may use information
13 provided by a financial institution under this section only for matching records under
14 sub. (4), for administering the financial record matching program under this section,
15 and for pursuing the collection of amounts owed to the department by debtors. The
16 department may not disclose or retain information received from a financial
17 institution under this section concerning account holders who are not debtors.

18 **(7) FINANCIAL INSTITUTION LIABILITY.** A financial institution is not liable to any
19 person for disclosing information to the department in accordance with an
20 agreement under this section or for any other action that the financial institution
21 takes in good faith to comply with this section.

1 (a) “Contribution” includes contributions under ss. 108.17 and 108.18, interest
2 for a nontimely payment or a fee assessed on an employer, an assessment under s.
3 108.19, any payment due for a forfeiture imposed upon an employing unit under s.
4 108.04 (11) (c), and any other penalty assessed by the department under this chapter
5 against an employing unit.

6 (b) “Credential” has the meaning given in s. 440.01 (2) (a), but does not include
7 a registration as an inactive licensee under s. 452.12 (6) (b).

8 (c) “Credentialing board” means a board, examining board or affiliated
9 credentialing board in the department of safety and professional services that grants
10 a credential.

11 (d) “Liable for delinquent contributions” means that a person has exhausted
12 all of the person’s remedies under s. 108.10 to challenge the assertion that the person
13 owes the department any contributions and the person is delinquent in the payment
14 of those contributions.

15 (e) “License” means any of the following:

- 16 1. An approval specified in s. 29.024 (2r) or a license specified in s. 169.35.
- 17 2. A license issued by the department of children and families under s. 48.66
18 (1) (a) to a child welfare agency, group home, shelter care facility, or child care center,
19 as required by s. 48.60, 48.625, 48.65, or 938.22 (7).
- 20 3. A license, certificate of approval, provisional license, conditional license,
21 certification, certification card, registration, permit, training permit or approval
22 specified in s. 50.35, 50.49 (6) (a) or (10), 51.038, 51.04, 51.42 (7) (b) 11., 51.421 (3)
23 (a), 51.45 (8), 146.40 (3) or (3m), 252.23 (2), 252.24 (2), 254.176, 254.20 (3), 255.08 (2)
24 (a), 256.15 (5) (a) or (b), (6g) (a), (7), or (8) (a) or (f) or 343.305 (6) (a) or a permit for
25 operation of a campground specified in s. 254.47 (1).

1 5. A license, as defined in s. 101.02 (20) (a).

2 6. A license or certificate of registration issued by the department of financial
3 institutions, or a division of it, under ss. 138.09, 138.12, 138.14, 217.06, 218.0101 to
4 218.0163, 218.02, 218.04, 218.05, 224.72, 224.725, 224.93 or under subch. IV of ch.
5 551.

6 7. A license described in s. 218.0114 (14) (a) and (g), a license described in s.
7 218.0114 (14) (b), (c) or (e), a license issued under s. 218.11, 218.12, 218.22, 218.32,
8 218.41, 343.61 or 343.62, a buyer identification card issued under s. 218.51 or a
9 certificate of registration issued under s. 341.51.

10 7m. A license issued under s. 562.05 or 563.24.

11 8. A license, registration or certification specified in s. 299.07 (1) (a).

12 9. A credential.

13 10. A license or permit granted by the department of public instruction.

14 11. A license to practice law.

15 12. A license issued under s. 628.04, 632.69 (2), or 633.14 or a temporary license
16 issued under s. 628.09.

17 13. A license issued by the government accountability board under s. 13.63 (1).

18 14. A permit under s. 170.12.

19 15. A certificate under s. 73.03 (50) or a certification under s. 73.09.

20 (f) “Licensing department” means the department of administration; the board
21 of commissioners of public lands; the department of children and families; the
22 government accountability board; the department of financial institutions; the
23 department of health services; the department of natural resources; the department
24 of public instruction; the department of revenue; the department of safety and

1 professional services; the office of the commissioner of insurance; or the department
2 of transportation.

3 (g) "Nondelinquency certificate" means a certificate that the department of
4 workforce development issues to a person and that states that the person is not liable
5 for delinquent contributions.

6 **(2) DUTIES AND POWERS OF LICENSING DEPARTMENTS.** (a) Each licensing
7 department and the supreme court, if the supreme court agrees, shall enter into a
8 memorandum of understanding with the department of workforce development
9 under sub. (4) (a) that requires the licensing department or supreme court to do all
10 of the following:

11 1. Request the department of workforce development to certify whether an
12 applicant for a license or license renewal or continuation is liable for delinquent
13 contributions. With respect to an applicant for a license granted by a credentialing
14 board, the department of safety and professional services shall make a request under
15 this subdivision. This subdivision does not apply to the department of transportation
16 with respect to licenses described in sub. (1) (e) 7.

17 2. Request the department of workforce development to certify whether a
18 license holder is liable for delinquent contributions. With respect to a holder of a
19 license granted by a credentialing board, the department of safety and professional
20 services shall make a request under this subdivision.

21 (b) Each licensing department and the supreme court, if the supreme court
22 agrees, shall do all of the following:

23 1. a. If, after a request is made under par. (a) 1. or 2., the department of
24 workforce development certifies that the license holder or applicant for a license or
25 license renewal or continuation is liable for delinquent contributions, revoke the

1 license or deny the application for the license or license renewal or continuation. The
2 department of transportation may suspend licenses described in sub. (1) (e) 7. in lieu
3 of revoking those licenses. A suspension, revocation, or denial under this subd. 1. a.
4 is not subject to administrative review or, except as provided in sub. (6), judicial
5 review. With respect to a license granted by a credentialing board, the department
6 of safety and professional services shall make a revocation or denial under this subd.
7 1. a. With respect to a license to practice law, the department of workforce
8 development shall not submit a certification under this subd. 1. a. to the supreme
9 court until after the license holder or applicant has exhausted his or her remedies
10 under subs. (5) (a) and (6) or has failed to make use of such remedies.

11 b. Mail a notice of suspension, revocation, or denial under subd. 1. a. to the
12 license holder or applicant. The notice shall include a statement of the facts that
13 warrant the suspension, revocation, or denial and a statement that the license holder
14 or applicant may, within 30 days after the date on which the notice of suspension,
15 revocation, or denial is mailed, file a written request with the department of
16 workforce development to have the certification of contribution delinquency on
17 which the suspension, revocation, or denial is based reviewed at a hearing under sub.
18 (5) (a) and that the license holder or applicant may seek judicial review under sub.
19 (6) of an affirmation under sub. (5) (b) 2. that the person is liable for delinquent
20 contributions. With respect to a license granted by a credentialing board, the
21 department of safety and professional services shall mail a notice under this subd.
22 1. b. With respect to a license to practice law, the department of workforce
23 development shall mail a notice under this subd. 1. b. and the notice shall indicate
24 that the license holder or applicant may request a hearing under sub. (5) (a) and may
25 request judicial review under sub. (6) and that the department of workforce

1 development will submit a certificate of delinquency to suspend, revoke, or deny a
2 license to practice law to the supreme court after the license holder or applicant has
3 exhausted his or her remedies under subs. (5) (a) and (6) or has failed to make use
4 of such remedies. A notice sent to a person who holds a license to practice law or who
5 is an applicant for a license to practice law shall also indicate that the department
6 of workforce development may not submit a certificate of delinquency to the supreme
7 court if the license holder or applicant pays the delinquent contributions in full or
8 enters into an agreement with the department of workforce development to satisfy
9 the delinquency.

10 2. Except as provided in subd. 2m., if notified by the department of workforce
11 development that the department of workforce development has affirmed a
12 certification of contribution delinquency after a hearing under sub. (5) (a), affirm a
13 suspension, revocation, or denial under subd. 1. a. With respect to a license granted
14 by a credentialing board, the department of safety and professional services shall
15 make an affirmation under this subdivision.

16 2m. With respect to a license to practice law, if notified by the department of
17 workforce development that the department of workforce development has affirmed
18 a certification of contribution delinquency after any requested review under subs. (5)
19 (a) and (6), decide whether to suspend, revoke, or deny a license to practice law.

20 3. If a person submits a nondelinquency certificate issued under sub. (5) (b) 1.,
21 reinstate the license or grant the application for the license or license renewal or
22 continuation, unless there are other grounds for suspending or revoking the license
23 or for denying the application for the license or license renewal or continuation. If
24 reinstatement is required under this subdivision, a person is not required to submit
25 a new application or other material or to take a new test. No separate fee may be

1 charged for reinstatement of a license under this subdivision. With respect to a
2 license granted by a credentialing board, the department of safety and professional
3 services shall reinstate a license or grant an application under this subdivision.

4 4. If a person whose license has been suspended or revoked or whose
5 application for a license or license renewal or continuation has been denied under
6 subd. 1. a. submits a nondelinquency certificate issued under sub. (3) (a) 2., reinstate
7 the license or grant the person's application for the license or license renewal or
8 continuation, unless there are other grounds for not reinstating the license or for
9 denying the application for the license or license renewal or continuation. With
10 respect to a license granted by a credentialing board, the department of safety and
11 professional services shall reinstate a license or grant an application under this
12 subdivision.

13 (c) 1. Each licensing department and the supreme court may require a license
14 holder or an applicant for a license or license renewal or continuation to provide the
15 following information upon request:

16 a. If the license holder or applicant is an individual and has a social security
17 number, the license holder's or applicant's social security number.

18 am. If the license holder or applicant is an individual and does not have a social
19 security number, a statement made or subscribed under oath or affirmation that the
20 license holder or applicant does not have a social security number. The form of the
21 statement shall be prescribed by the department of children and families. A license
22 issued in reliance upon a false statement submitted under this subd. 1. am. is invalid.

23 b. If the license holder or applicant is not an individual, the license holder's or
24 applicant's federal employer identification number.

1 2. A licensing department may not disclose any information received under
2 subd. 1. a. or b. to any person except to the department of workforce development for
3 the purpose of requesting certifications under par. (a) 1. or 2. in accordance with the
4 memorandum of understanding under sub. (4) and administering the
5 unemployment insurance program, to the department of revenue for the purpose of
6 requesting certifications under s. 73.0301 (2) (a) 1. or 2. in accordance with the
7 memorandum of understanding under s. 73.0301 (4) and administering state taxes,
8 and to the department of children and families for the purpose of administering s.
9 49.22.

10 **(3) DUTIES AND POWERS OF DEPARTMENT OF WORKFORCE DEVELOPMENT.** (a) The
11 department of workforce development shall do all of the following:

12 1. Enter into a memorandum of understanding with each licensing department
13 and the supreme court, if the supreme court agrees, under sub. (4) (a).

14 2. Upon the request of any applicant for issuance, renewal, continuation, or
15 reinstatement of a license whose license has been previously revoked or suspended
16 or whose application for a license or license renewal or continuation has been
17 previously denied under sub. (2) (b) 1. a., issue a nondelinquency certificate to the
18 applicant if the applicant is not liable for delinquent contributions.

19 3. Upon the request of any person whose license or certificate has been
20 previously revoked or denied under s. 102.17 (1) (ct), 103.275 (2) (bt), 103.34 (10) (d),
21 103.91 (4) (d), 103.92 (8), 104.07 (7), or 105.13 (4), reinstate the license or certificate
22 if the applicant is not liable for delinquent contributions.

23 (b) If a request for certification is made under sub. (2) (a) 1. or 2., the
24 department of workforce development may, in accordance with a memorandum of
25 understanding entered into under par. (a) 1., certify to the licensing department or

1 the supreme court that the applicant or license holder is liable for delinquent
2 contributions.

3 (4) MEMORANDUM OF UNDERSTANDING. (a) Each memorandum of understanding
4 shall include procedures that do all of the following:

5 1. Establish requirements for making requests under sub. (2) (a) 1. and 2.,
6 including specifying the time when a licensing department or the supreme court
7 shall make requests under sub. (2) (a) 1. and 2., and for making certifications under
8 sub. (3) (b).

9 2. Implement the requirements specified in sub. (2) (b) 3. and 4.

10 (b) The department of workforce development and the licensing department
11 shall consider all of the following factors in establishing requirements under par. (a)
12 1.:

13 1. The need to issue licenses in a timely manner.

14 2. The convenience of applicants.

15 3. The impact on collecting delinquent contributions.

16 4. The effects on program administration.

17 5. Whether a suspension, revocation, or denial under sub. (2) (b) 1. a. will have
18 an impact on public health, safety, or welfare or the environment.

19 (5) HEARING. (a) The department of workforce development shall conduct a
20 hearing requested by a license holder or applicant for a license or license renewal or
21 continuation under sub. (2) (b) 1. b., or as requested under s. 102.17 (1) (ct), 103.275
22 (2) (bt), 103.34 (10) (d), 103.91 (4) (d), 103.92 (8), 104.07 (7), or 105.13 (4), to review
23 a certification or determination of contribution delinquency that is the basis of a
24 denial, suspension, or revocation of a license or certificate in accordance with this
25 section or an action taken under s. 102.17 (1) (ct), 103.275 (2) (bt), 103.34 (10) (d),

1 103.91 (4) (d), 103.92 (8), 104.07 (7), or 105.13 (4). A hearing under this paragraph
2 is limited to questions of mistaken identity of the license or certificate holder or
3 applicant and of prior payment of the contributions that the department of workforce
4 development certified or determined the license or certificate holder or applicant
5 owes the department. At a hearing under this paragraph, any statement filed by the
6 department of workforce development, the licensing department, or the supreme
7 court, if the supreme court agrees, may be admitted into evidence and is prima facie
8 evidence of the facts that it contains. Notwithstanding ch. 227, a person entitled to
9 a hearing under this paragraph is not entitled to any other notice, hearing, or review,
10 except as provided in sub. (6).

11 (b) After a hearing conducted under par. (a) or, in the case of a determination
12 related to a license to practice law, after a hearing under par. (a) or, if the hearing is
13 appealed, after judicial review under sub. (6), the department of workforce
14 development shall do one of the following:

15 1. Issue a nondelinquency certificate to a license holder or an applicant for a
16 license or license renewal or continuation if the department determines that the
17 license holder or applicant is not liable for delinquent contributions. For a hearing
18 requested in response to an action taken under s. 102.17 (1) (ct), 103.275 (2) (bt),
19 103.34 (10) (d), 103.91 (4) (d), 103.92 (8), 104.07 (7), or 105.13 (4), the department
20 shall grant a license or certificate or reinstate a license or certificate if the
21 department determines that the applicant for or the holder of the license or
22 certificate is not liable for delinquent contributions, unless there are other grounds
23 for denying the application or revoking the license or certificate.

24 2. Provide notice that the department of workforce development has affirmed
25 its certification of contribution delinquency to a license holder; to an applicant for a

1 license, a license renewal, or a license continuation; and to the licensing department
2 or the supreme court, if the supreme court agrees. For a hearing requested in
3 response to an action taken under s. 102.17 (1) (ct), 103.275 (2) (bt), 103.34 (10) (d),
4 103.91 (4) (d), 103.92 (8), 104.07 (7), or 105.13 (4), the department of workforce
5 development shall provide notice to the license or certificate holder or applicant that
6 the department of workforce development has affirmed its determination of
7 contribution delinquency.

8 (6) JUDICIAL REVIEW. A license holder or applicant may seek judicial review
9 under ss. 227.52 to 227.60 of an affirmation under sub. (5) (b) 2. that the person is
10 liable for delinquent contributions, except that the review shall be in the circuit court
11 for Dane County.


