2 1. Page 75, line 7: after that line insert:

3 **(1m)** GENERAL PROVISIONS. The department shall promulgate rules with
 4 regards to procedures to be used before taking action under sub. (3) (b) or s. 102.17
 5 (1) (ct), 103.275 (2) (bt), 103.34 (10) (d), 103.91 (4) (d), 103.92 (8), 104.07 (7), or 105.13
 6 (4) with respect to a *pe* person whose license or credential is to be denied, not renewed,
 7 discontinued, suspended, or revoked, including rules with respect to all of the
 8 following:

9 (a) Permitting the department to take action only when all of the remedies
10 available to the department under this chapter have been exhausted.

11 (b) Providing persons with a certified notice of liability for delinquent
12 contributions.
