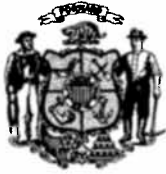

- 2 1. Page 6, line 21: after "performed" insert "or refused".
- 3 2. Page 7, line 3: after "ultrasound" insert "is refused or the".
- 4 3. Page 9, line 6: after "under" insert "par. (b) and".
- 5 4. Page 10, line 3: after "heartbeat." insert "No person may physically force a
- 6 pregnant woman to undergo an ultrasound".
- 7 5. Page 10, line 5: after "heartbeat" insert "or refuses to undergo an
- 8 ultrasound".
- 9 6. Page 10, line 15: after "are satisfied." insert "If the pregnant woman refuses
- 10 to undergo an ultrasound, the physician shall certify on the form that she refuses".
