At the locations indicated, amend the bill as follows:

1. Page 11, line 18: after that line insert:

"SECTION 13g. 632.895 (16g) of the statutes is created to read:

632.895 (16g) MANDATORY ULTRASOUNDS BEFORE ABORTION. (a) Every disability insurance policy, every self-insured health plan of the state or of a county, city, town, village, or school district, and every defined network plan, as defined in s. 609.01 (1b), that provides coverage of outpatient health care services or preventive treatments and services shall provide coverage for an ultrasound required under s. 253.10 (3g).

(b) Coverage under par. (a) may be subject only to the exclusions, limitations, or cost-sharing provisions that apply generally to the coverage of outpatient health care services or preventive treatments and services that is provided under the policy, self-insured health plan, or defined network plan.

(c) This subsection does not apply to any of the following:
