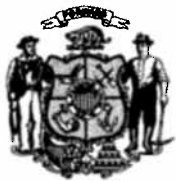

- 2 1. Page 7, line 3: after "performed" insert "or refused".
- 3 2. Page 7, line 10: after "ultrasound" insert "is refused or the".
- 4 3. Page 9, line 13: after "under" insert "par. (am) and".
- 5 4. Page 9, line 18: delete "following:" and substitute "following, after obtaining
- 6 consent under par. (am):".
- 7 5. Page 10, line 10: after that line insert:
- 8 "(am) No person may perform an ultrasound to satisfy the requirements of this
- 9 subsection without first obtaining the consent of the pregnant woman on whom the
- 10 ultrasound is to be performed. If the woman does not consent to the ultrasound, the
- 11 requirements of par. (a) are considered satisfied. No person may force a woman to
- 12 consent to an ultrasound under this subsection."
