**ASSEMBLY AMENDMENT ,
TO ASSEMBLY BILL 179**

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 2: after “contracts” insert “and requiring the board of directors
3 of the Wisconsin Economic Development Corporation to submit to the legislature a
4 quarterly report identifying the number of jobs that have been created in this state
5 during the past 90 days resulting from the economic development projects of the
6 corporation”.

7 **2.** Page 3, line 4: after that line insert:

8 “SECTION 2h. 238.07 (title) of the statutes is amended to read:

9 **238.07 (title) Submission of annual reports to legislature.**

10 **SECTION 2p.** 238.07 (4) of the statutes is created to read:

11 238.07 (4) On a quarterly basis, the board shall submit to the chief clerk of each
12 house of the legislature, for distribution to the legislature under s. 13.172 (2), a report

1 identifying the number of jobs that have been created in this state during the past
2 90 days resulting from the economic development projects of the corporation.”
