1 AN ACT *to renumber and amend* 551.605 (3); *to amend* 551.102 (11) (o),
2 551.305 (9), 551.401 (1), 551.402 (2) (b) and 551.402 (2) (f); and *to create* 227.01
3 (13) (zz), 551.102 (4m), 551.102 (8m), 551.102 (9m), 551.202 (13) (ar), 551.202
4 (14m), 551.202 (24m), 551.202 (26), 551.202 (27), 551.205, 551.206, 551.605 (3)
5 (bm), 551.607 (2) (g) and 551.614 (1m) of the statutes; **relating to:** exemptions
6 from securities registration requirements, reporting by certain financial
7 institution holding companies, and granting rule-making authority.

The people of the state of Wisconsin, represented in senate and assembly, do enact as follows:

8 SECTION 1. 227.01 (13) (zz) of the statutes is created to read:
9 227.01 (13) (zz) Adjusts, under s. 551.206, the amounts specified in s. 551.202
10 (26) (c) 1. a. and 1. b. and (27) (c) 1. a. and 1. b.

1 **SECTION 2.** 551.102 (4m) of the statutes is created to read:

2 551.102 (4m) “Certified investor” means an individual who is a resident of this
3 state and who, at the time of an offer or sale of securities, satisfies any of the
4 following:

5 (a) Has an individual net worth, or joint net worth with the individual’s spouse,
6 of at least \$750,000. For purposes of calculating net worth under this paragraph, the
7 individual’s primary residence shall be included as an asset and indebtedness
8 secured by the primary residence shall be included as a liability.

9 (b) Had an individual income in excess of \$100,000 in each of the two most
10 recent years or joint income with the individual’s spouse in excess of \$150,000 in each
11 of those years and has a reasonable expectation of reaching the same income level
12 in the current year.

13 **SECTION 3.** 551.102 (8m) of the statutes is created to read:

14 551.102 (8m) “Financial institution holding company” means a bank holding
15 company, as defined in 12 USC 1841 (a), or a savings and loan holding company, as
16 defined in 12 USC 1467a (a) (1) (D).

17 **SECTION 4.** 551.102 (9m) of the statutes is created to read:

18 551.102 (9m) “Funding portal” has the meaning given in section 3 (a) (80) of
19 the Securities Exchange Act of 1934 (15 USC 78c (a) (80)).

20 **SECTION 5.** 551.102 (11) (o) of the statutes is amended to read:

21 551.102 (11) (o) Any other person, other than an individual, of institutional
22 character with total assets in excess of ~~\$10,000,000~~ \$2,500,000 not organized for the
23 specific purpose of evading this chapter.

24 **SECTION 6.** 551.202 (13) (ar) of the statutes is created to read:

1 551.202 (13) (ar) A certified investor, or a person whom the issuer reasonably
2 believes is a certified investor at the time of the sale or offer of the security, if the
3 transaction meets the requirements of the federal exemption for intrastate offerings
4 in section 3 (a) (11) of the Securities Act of 1933 (15 USC 77c (a) (11)) and Rule 147
5 adopted under the Securities Act of 1933 (17 CFR 230.147).

6 SECTION 7. 551.202 (14m) of the statutes is created to read:

7 551.202 (14m) (a) Any transaction pursuant to an offer directed by the offeror
8 to not more than 100 persons in ^{residents of} this state, excluding those persons designated in sub.
9 (13) ^{(a), (am), and} (ar) but including persons exempt under sub. [§] (13) (a) and (am) and (24), if all
10 of the following apply:

11 1. The transaction, if consummated, meets the requirements of the federal
12 exemption for intrastate offerings in section 3 (a) (11) of the Securities Act of 1933
13 (15 USC 77c (a) (11)) and Rule 147 adopted under the Securities Act of 1933 (17 CFR
14 230.147).

15 2. No commission or other remuneration is paid or given, directly or indirectly,
16 for any person's participation in the offer or sale of securities for the issuer unless the
17 person is registered as a broker-dealer or agent under this chapter.

18 3. No general solicitation or general advertising is made in connection with the
19 offer to sell or sale of the securities unless it has been permitted by the administrator.

20 (b) The exemption under this subsection and the exemption under sub. (27)
21 may be used in conjunction with each other.

22 SECTION 8. 551.202 (24m) of the statutes is created to read:

23 551.202 (24m) Any offer or sale of its securities by an issuer ^{to residents of this state} during any period
24 of 12 consecutive months, if all of the following apply:

1 (a) The issuer is a business entity that is organized under the laws of this state
2 and authorized to do business in this state and that has its principal office in this
3 state.

4 (b) The aggregate number of persons holding directly or indirectly all of the
5 issuer's securities, after the securities to be issued are sold, does not exceed 100,
6 exclusive of persons under sub. (13)(ar). (a), (am), and

7 (c) During this 12-month period, any offer or sale of the issuer's securities is
8 made only to residents of this state.

9 **SECTION 9.** 551.202 (26) of the statutes is created to read:

10 551.202 (26) An offer or sale of a security by an issuer if the offer or sale is
11 conducted in accordance with all of the following requirements:

12 (a) The issuer of the security is a business entity organized under the laws of
13 this state and authorized to do business in this state.

14 (b) The transaction meets the requirements of the federal exemption for
15 intrastate offerings in section 3 (a) (11) of the Securities Act of 1933 (15 USC 77c (a)
16 (11)) and Rule 147 adopted under the Securities Act of 1933 (17 CFR 230.147).

17 (c) 1. Except as provided in subd. 2., the sum of all cash and other consideration
18 to be received for all sales of the security in reliance on the exemption under this
19 subsection, excluding sales to any accredited investor, certified investor, or
20 institutional investor, does not exceed the following amount:

21 a. If the issuer has not undergone and made available to each prospective
22 investor and the administrator the documentation resulting from a financial audit
23 of its most recently completed fiscal year which complies with generally accepted
24 accounting principles, \$1,000,000 subject to adjustment under s. 551.206, less the
25 aggregate amount received for all sales of securities by the issuer within the 12

3 b. If the issuer has undergone and made available to each prospective investor
4 and the administrator the documentation resulting from a financial audit of its most
5 recently completed fiscal year which complies with generally accepted accounting
6 principles, \$2,000,000 subject to adjustment under s. 551.206, less the aggregate
7 amount received for all sales of securities by the issuer within the 12 months before
8 the first offer or sale made in reliance on the exemption under this subsection.

9 2. An offer or sale to an officer, director, partner, trustee, or individual
10 occupying similar status or performing similar functions with respect to the issuer
11 or to a person owning 10 percent or more of the outstanding shares of any class or
12 classes of securities of the issuer does not count toward the monetary limitation in
13 subd. 1. a. and 1. b.

14 (d) The issuer does not accept more than \$5,000 from any single purchaser
15 unless the purchaser is an accredited investor or certified investor.

16 (e) The offering under this subsection is made exclusively through one or more
17 Internet sites and each Internet site is registered with the division under s. 551.205
18 (1) (b).

19 (f) Not less than 10 days prior to the commencement of an offering of securities
20 in reliance on the exemption under this subsection, the issuer files a notice with the
21 administrator, in writing or in electronic form as prescribed by the administrator,
22 which the administrator shall make available as an electronic document on the
23 department of financial institutions Internet site, containing all of the following:

1 1. A notice of claim of exemption from registration, specifying that the issuer
2 will be conducting an offering in reliance on the exemption under this subsection,
3 accompanied by the filing fee specified in s. 551.614 (1m).

4 2. A copy of the disclosure statement to be provided to prospective investors in
5 connection with the offering, containing all of the following:

6 a. A description of the company, its type of entity, the address and telephone
7 number of its principal office, its history, its business plan, and the intended use of
8 the offering proceeds, including any amounts to be paid, as compensation or
9 otherwise, to any owner, executive officer, director, managing member, or other
10 person occupying a similar status or performing similar functions on behalf of the
11 issuer.

12 b. The identity of all persons owning more than 10 percent of the ownership
13 interests of any class of securities of the company.

14 c. The identity of the executive officers, directors, managing members, and
15 other persons occupying a similar status or performing similar functions in the name
16 of and on behalf of the issuer, including their titles and their prior experience.

17 d. The terms and conditions of the securities being offered and of any
18 outstanding securities of the company; the minimum and maximum amount of
19 securities being offered, if any; either the percentage ownership of the company
20 represented by the offered securities or the valuation of the company implied by the
21 price of the offered securities; the price per share, unit, or interest of the securities
22 being offered; any restrictions on transfer of the securities being offered; and a
23 disclosure of any anticipated future issuance of securities that might dilute the value
24 of securities being offered.

1 e. The identity of any person who has been or will be retained by the issuer to
2 assist the issuer in conducting the offering and sale of the securities, including any
3 Internet site operator but excluding persons acting solely as accountants or
4 attorneys and employees whose primary job responsibilities involve the operating
5 business of the issuer rather than assisting the issuer in raising capital.

6 f. For each person identified as required under subd. 2. e., a description of the
7 consideration being paid to the person for such assistance.

8 g. A description of any litigation or legal proceedings involving the company or
9 its management.

10 h. The names and addresses, including the Uniform Resource Locator, of each
11 Internet site that will be used by the issuer to offer or sell securities under this
12 subsection.

13 i. Any additional information material to the offering, including, if appropriate,
14 a discussion of significant factors that make the offering speculative or risky. This
15 discussion shall be concise and organized logically and may not be limited to risks
16 that could apply to any issuer or any offering.

17 3. An escrow agreement with a bank, savings bank, savings and loan
18 association, or credit union chartered under the laws of this state in which the
19 investor funds will be deposited, providing that all offering proceeds will be released
20 to the issuer only when the aggregate capital raised from all investors is equal to or
21 greater than the minimum target offering amount specified in the business plan as
22 necessary to implement the business plan and that all investors may cancel their
23 commitments to invest if that target offering amount is not raised by the time stated
24 in the disclosure document.

1 (g) The issuer is not, either before or as a result of the offering, an investment
2 company, as defined in section 3 of the Investment Company Act of 1940 (15 USC
3 80a-3), or an entity that would be an investment company but for the exclusions
4 provided in section 3 (c) of the Investment Company Act of 1940 (15 USC 80a-3 (c)),
5 or subject to the reporting requirements of section 13 or 15 (d) of the Securities
6 Exchange Act of 1934 (15 USC 78m or 78o (d)).

7 (h) The issuer informs all prospective purchasers of securities offered under
8 this subsection that the securities have not been registered under federal or state
9 securities law and that the securities are subject to limitations on resale. The issuer
10 shall display the following legend conspicuously on the cover page of the disclosure
11 document:

12 IN MAKING AN INVESTMENT DECISION, INVESTORS MUST RELY ON
13 THEIR OWN EXAMINATION OF THE ISSUER AND THE TERMS OF THE
14 OFFERING, INCLUDING THE MERITS AND RISKS INVOLVED. THESE
15 SECURITIES HAVE NOT BEEN RECOMMENDED BY ANY FEDERAL OR
16 STATE SECURITIES COMMISSION OR DIVISION OR OTHER REGULATORY
17 AUTHORITY. FURTHERMORE, THE FOREGOING AUTHORITIES HAVE NOT
18 CONFIRMED THE ACCURACY OR DETERMINED THE ADEQUACY OF THIS
19 DOCUMENT. ANY REPRESENTATION TO THE CONTRARY IS A CRIMINAL
20 OFFENSE. THESE SECURITIES ARE SUBJECT TO RESTRICTIONS ON
21 TRANSFERABILITY AND RESALE AND MAY NOT BE TRANSFERRED OR
22 RESOLD EXCEPT AS PERMITTED BY SUBSECTION (e) OF SEC RULE 147 (17
23 CFR 230.147 (e)) AS PROMULGATED UNDER THE SECURITIES ACT OF 1933,
24 AS AMENDED, AND THE APPLICABLE STATE SECURITIES LAWS,
25 PURSUANT TO REGISTRATION OR EXEMPTION THEREFROM. INVESTORS

1 SHOULD BE AWARE THAT THEY WILL BE REQUIRED TO BEAR THE
2 FINANCIAL RISKS OF THIS INVESTMENT FOR AN INDEFINITE PERIOD OF
3 TIME.

4 (i) The issuer requires each purchaser to certify in writing or electronically as
5 follows:

6 I UNDERSTAND AND ACKNOWLEDGE THAT:

7 I am investing in a high-risk, speculative business venture. I may lose all of
8 my investment, or under some circumstances more than my investment, and I can
9 afford this loss.

10 This offering has not been reviewed or approved by any state or federal
11 securities commission or division or other regulatory authority and that no such
12 person or authority has confirmed the accuracy or determined the adequacy of any
13 disclosure made to me relating to this offering.

14 The securities I am acquiring in this offering are illiquid, that there is no ready
15 market for the sale of such securities, that it may be difficult or impossible for me to
16 sell or otherwise dispose of this investment, and that, accordingly, I may be required
17 to hold this investment indefinitely.

18 I may be subject to tax on my share of the taxable income and losses of the
19 company, whether or not I have sold or otherwise disposed of my investment or
20 received any dividends or other distributions from the company.

21 (Signature)

22 (j) The issuer obtains from each purchaser of a security offered under this
23 subsection evidence that the purchaser is a resident of this state and, if applicable,
24 is an accredited investor or certified investor.

1 (k) All payments for purchase of securities offered under this subsection are
2 directed to and held by the financial institution specified in par. (f) 3. The bank or
3 depository institution shall notify the administrator of the receipt of payments for
4 securities. This information shall be confidential as provided in s. 551.607 (2) (g).

5 (L) The issuer of securities offered under this subsection provides a copy of the
6 disclosure document provided to the administrator under par. (f) 2. to each
7 prospective investor at the time the offer of securities is made to the prospective
8 investor.

9 (m) No offer or sale of a different class or series of security has been made by
10 the issuer in reliance on the exemption under this subsection or sub. (27) during the
11 immediately preceding 12-month period.

12 **SECTION 10.** 551.202 (27) of the statutes is created to read:

13 551.202 (27) An offer or sale of a security by an issuer if the offer or sale is
14 conducted in accordance with all of the following requirements:

15 (a) The issuer of the security is a business entity organized under the laws of
16 this state and authorized to do business in this state.

17 (b) The transaction meets the requirements of the federal exemption for
18 intrastate offerings in section 3 (a) (11) of the Securities Act of 1933 (15 USC 77c (a)
19 (11)) and Rule 147 adopted under the Securities Act of 1933 (17 CFR 230.147).

20 (c) 1. Except as provided in subd. 2., the sum of all cash and other consideration
21 to be received for all sales of the security in reliance on the exemption under this
22 subsection, excluding sales to any accredited investor, certified investor, or
23 institutional investor, does not exceed the following amount:

24 a. If the issuer has not undergone and made available to each prospective
25 investor and the administrator the documentation resulting from a financial audit

1 of its most recently completed fiscal year which complies with generally accepted
2 accounting principles, \$1,000,000 subject to adjustment under s. 551.206, less the
3 aggregate amount received for all sales of securities by the issuer within the 12

1 (g) All funds received from investors are deposited into a bank, savings bank,
2 savings and loan association, or credit union chartered under the laws of this state,
3 and all the funds are used in accordance with representations made to investors.

4 (h) Before the ^{10/5+} 100th offer of the security, the issuer provides a notice to the
5 administrator in writing or in electronic form, accompanied by the filing fee specified
6 in s. 551.614 (1m). The administrator shall prescribe the form required for the notice
7 and make the form available as an electronic document on the department of
8 financial institutions Internet site. Notwithstanding s. 551.204 (1) and (3), the
9 notice shall be limited to all of the following:

10 1. Stating that the issuer is conducting an offering in reliance on the exemption
11 under this subsection.

12 2. Identifying the names and addresses of all of the following persons:

13 a. The issuer.

14 b. All persons who will be involved in the offer or sale of securities on behalf of
15 the issuer.

16 c. The bank, savings bank, savings and loan association, or credit union in
17 which investor funds will be deposited.

18 (i) The issuer is not, either before or as a result of the offering, an investment
19 company, as defined in section 3 of the Investment Company Act of 1940 (15 USC
20 80a-3), or subject to the reporting requirements of section 13 or 15 (d) of the
21 Securities Exchange Act of 1934 (15 USC 78m or 78o (d)).

22 (j) The issuer informs all purchasers that the securities have not been
23 registered under this chapter and makes the disclosures required under subsection
24 (f) of Rule 147 adopted under the Securities Act of 1933 (17 CFR 230.147 (f)).

1 (k) No offer or sale of a different class or series of security has been made by
2 the issuer in reliance on the exemption under this subsection or sub. (26) during the
3 immediately preceding 12-month period.

4 **SECTION 11.** 551.205 of the statutes is created to read:

5 **551.205 Additional provisions related to crowdfunding exemption for**
6 **intrastate offerings through Internet sites.** (1) All of the following
7 requirements apply to an offer or sale of securities pursuant to the exemption under
8 s. 551.202 (26):

9 (a) Prior to any offer or sale of securities, the issuer shall provide to the Internet
10 site operator evidence that the issuer is organized under the laws of this state and
11 is authorized to do business in this state.

12 (b) 1. The Internet site operator shall register with the division by filing a
13 statement, which the administrator shall make available as an electronic document
14 on the department of financial institutions Internet site, accompanied by the filing
15 fee specified in s. 551.614 (1m), that includes all of the following:

16 a. That the Internet site operator is a business entity organized under the laws
17 of this state and authorized to do business in this state.

18 b. That the Internet site is being utilized to offer and sell securities pursuant
19 to the exemption under s. 551.202 (26).

20 c. The identity and location of, and contact information for, the Internet site
21 operator.

22 d. Except as provided in subds. 2. and 4., that the Internet site operator is
23 registered as a broker-dealer under s. 551.401.

1 2. The Internet site operator is not required to register as a broker–dealer
2 under s. 551.401 if all of the following apply with respect to the Internet site and its
3 operator:

4 a. It does not offer investment advice or recommendations.

5 b. It does not solicit purchases, sales, or offers to buy the securities offered or
6 displayed on the Internet site.

7 c. Except as provided in sub. (3), it does not compensate employees, agents, or
8 other persons for the solicitation or based on the sale of securities displayed or
9 referenced on the Internet site.

10 d. Except as provided in sub. (3), it is not compensated based on the amount
11 of securities sold, and it does not hold, manage, possess, or otherwise handle investor
12 funds or securities.

13 e. Except as provided in sub. (3), the fee it charges an issuer for an offering of
14 securities on the Internet site is a fixed amount for each offering, a variable amount
15 based on the length of time that the securities are offered on the Internet site, or a
16 combination of such fixed and variable amounts.

17 f. It does not identify, promote, or otherwise refer to any individual security
18 offered on the Internet site in any advertising for the Internet site.

19 g. It does not engage in such other activities as the division, by rule, determines
20 are prohibited of such an Internet site.

21 3. If any change occurs in the information that an Internet site operator
22 submits to the division in a statement filed under subd. 1., the Internet site operator
23 shall notify the division within 30 days after the change occurs.

24 4. The Internet site operator is not required to register as a broker–dealer
25 under s. 551.401 if the Internet site operator is registered as a broker–dealer under

1 the Securities Exchange Act of 1934 (15 USC 78o) or is a funding portal registered
2 under the Securities Act of 1933 (15 USC 77d–1) and the Securities and Exchange
3 Commission has adopted rules under authority of section 3 (h) of the Securities
4 Exchange Act of 1934 (15 USC 78c (h)) and P.L. 112–106, section 304, governing
5 funding portals. Nothing in this section requires an Internet site operator to register
6 as a broker–dealer under the Securities Exchange Act of 1934 or as a funding portal
7 under the Securities Act of 1933.

8 (c) The issuer and the Internet site operator shall maintain records of all offers
9 and sales of securities effected through the Internet site and shall provide ready
10 access to the records to the division, upon request. The division may access, inspect,
11 and review any Internet site registered under this subsection as well as its records.

12 (2) An issuer of a security, the offer and sale of which is exempt under s. 551.202
13 (26), shall provide, free of charge, a quarterly report to the issuer’s investors until no
14 securities issued under s. 551.202 (26) are outstanding. An issuer may satisfy the
15 reporting requirement of this subsection by making the information available on an
16 Internet site if the information is made available within 45 days after the end of each
17 fiscal quarter and remains available until the succeeding quarterly report is issued.
18 An issuer shall file each quarterly report under this subsection with the division and,
19 if the quarterly report is made available on an Internet site, the issuer shall also
20 provide a written copy of the report to any investor upon request. The report shall
21 contain all of the following:

22 (a) Compensation received by each director and executive officer, including
23 cash compensation earned since the previous report and on an annual basis and any
24 bonuses, stock options, other rights to receive securities of the issuer or any affiliate
25 of the issuer, or other compensation received.

1 (b) An analysis by management of the issuer of the business operations and
2 financial condition of the issuer.

3 (3) If the Securities and Exchange Commission adopts rules under authority
4 of section 3 (h) of the Securities Exchange Act of 1934 (15 USC 78c (h)) and P.L.
5 112–106, section 304, that authorize funding portals to receive commissions without
6 registering as broker–dealers under the Securities Exchange Act of 1934, the
7 division ~~may~~ ^{shall} promulgate rules authorizing Internet site operators registered with
8 the division under sub. (1) (b) that are not registered as broker–dealers under s.
9 551.401 to receive commissions. insert 16-9

10 SECTION 12. 551.206 of the statutes is created to read:

11 **551.206 Adjustments.** At 5–year intervals after January 1, 2014, the
12 department of financial institutions shall adjust the monetary amounts specified in
13 s. 551.202 (26) (c) 1. a. and 1. b. and (27) (c) 1. a. and 1. b. to reflect changes since
14 January 1, 2014, in the consumer price index for all urban consumers,
15 Milwaukee–Racine area average, as determined by the U.S. department of labor.
16 Each adjustment shall be rounded to the nearest multiple of \$50,000. Each
17 adjustment under this section shall be published on the department of financial
18 institutions Internet site.

19 SECTION 13. 551.305 (9) of the statutes is amended to read:

20 551.305 (9) PERIODIC REPORTS. While a registration statement is effective, a rule
21 adopted or order issued under this chapter may require the person that filed the
22 registration statement to file reports, not more often than quarterly, to keep the
23 information or other record in the registration statement reasonably current and to
24 disclose the progress of the offering. No report may be required under this subsection
25 of a financial institution holding company.

1 **SECTION 14.** 551.401 (1) of the statutes is amended to read:

2 551.401 (1) **REGISTRATION REQUIREMENT.** It is unlawful for a person to transact
3 business in this state as a broker–dealer unless the person is registered under this
4 chapter as a broker–dealer or is exempt from registration as a broker–dealer under
5 sub. (2) or (4) or s. 551.205 (1) (b) 2.

6 **SECTION 15.** 551.402 (2) (b) of the statutes is amended to read:

7 551.402 (2) (b) An individual who represents a broker–dealer that is exempt
8 under s. 551.205 (1) (b) 2. or 551.401 (2) or (4).

9 **SECTION 16.** 551.402 (2) (f) of the statutes is amended to read:

10 551.402 (2) (f) An individual who represents a broker–dealer registered in this
