The bill already requires that we promulgate rules, so the best approach in terms of drafting and putting the new program into operation would be to have an applicability clause which states something like:

This section first applies to an apprentice who has successfully completed part or all of the requirements of his or her apprenticeship program on the 90th day after the department has promulgated the administrative rules required by sub. (6).

We could start with an emergency rule, which could be put into place within two or three months.
