AA to SB 331

November 5, 2013 - Offered by Representative HULSEY.

\*\*\*AUTHORS SUBJECT TO CHANGE\*\*\*

1 At the locations indicated, amend the bill as follows:

2 1. Page 1, line 2: after "grants" insert ", increasing state aid for technical  
3 colleges,".

4 2. Page 3, line 14: after that line insert:

5 "SECTION 3m. Fiscal changes.

6 (1) STATE AID FOR TECHNICAL COLLEGES. In the schedule under section 20.005 (3)  
7 of the statutes for the appropriation to the technical college system board under  
8 section 20.292 (1) (d) of the statutes, as affected by the acts of 2013, the dollar amount  
9 is increased by \$35,800,000 for the second fiscal year of the fiscal biennium in which  
10 this subsection takes effect to increase funding for the purpose for which the  
11 appropriation is made."
