2 **1.** Page 8, line 24: delete the material beginning with "school" and ending with
3 "section," on page 9, line 1, and substitute "school."

4 **2.** Page 9, line 8: delete "participating".

5 **3.** Page 9, line 12: delete the material beginning with that line and ending with
6 page 10, line 6 and substitute:

7 **"(5) PAYMENTS.** From the appropriation under s. 20.235 (1) (fw), the board shall
8 pay the district school in which a scholar is enrolled, on behalf of the scholar, an
9 amount not to exceed \$2,250 for each academic year in which the scholar receives a
10 higher education scholarship under sub. (4) (a) or (b)."
