SENATE AMENDMENT ,
TO ASSEMBLY BILL 61

1 At the locations indicated, amend the bill as follows:

2 **1.** Page 1, line 3: after “premises” insert “, grants to combat alcohol abuse in
3 youth and providing funds to local law enforcement, and making an appropriation”.

4 **2.** Page 2, line 1: before that line insert:

5 “SECTION 1g. 20.435 (5) (im) of the statutes is created to read:

6 20.435 (5) (im) *Grants to combat alcohol abuse in youth.* All moneys received
7 by the department under s. 125.07 (4) (f) 1. for grants under s. 46.975 (2) (c) to combat
8 alcohol abuse in youth.”.

9 **3.** Page 2, line 1: delete “SECTION 1” and substitute “SECTION 1m”.

10 **4.** Page 3, line 13: after “(a).” insert “If the licensee recovers damages under
11 this subdivision, from the total amount of damages recovered, the licensee shall
12 forward ~~50~~²⁵ percent to the department of health services, which amount shall be
13 deposited in the general fund and credited to the appropriation account under s.

1 20.435 (5) (im), 25 percent to the municipal law enforcement agency serving the area
2 where the violation of par. (a) occurred, ~~and~~ ² 25 percent to the county law enforcement
3 agency serving the area where the violation of par. (a) occurred.”
