20.370 (4) (kc) Sea lamprey control. As a continuing appropriation from the general fund, the amounts in the schedule for sea lamprey control projects under s. 23.22 (2) (f). No moneys may be encumbered from this appropriation after June 30, 2016. **Section 3.** 20.370 (4) (ku) of the statutes is amended to read: 20.370 (4) (ku) Great Lakes trout and salmon. All moneys received under ss. 29.219 (3) (c), 29.228 (7) (c), and 29.2285 (2) to provide additional funding for the trout and salmon rearing and stocking program for outlying waters and to administer s. 29.2285 (2), and for sea lamprey control projects under s. 23.22 (2) (d) and (e). **Section 4.** 23.22 (1) (bm) of the statutes is created to read: 23.22 (1) (bm) "Governmental unit" means a federal agency, state agency, county, city, village, or town. **Section 5.** 23.22 (2) (d) of the statutes is created to read: 23.22 (2) (d) Under the program established under par. (a), the department shall set aside \$42,000 from the appropriation under s. 20.370 (4) (ku) during fiscal year 2013-14 to be used for a project to improve the sea lamprey barrier on the Kewaunee River at the Besadny Anadromous Fish Facility. Upon either the receipt or commitment of funding in the amount of \$78,000 from one or more governmental units, the department shall release the amount set aside for the project. **Section 6.** 23.22 (2) (e) of the statutes is created to read: 23.22 (2) (e) Under the program established under par. (a), the department shall set aside \$262,500 from the appropriation under s. 20.370 (4) (ku) during fiscal year 2013-14 to be used for a project to construct a sea lamprey barrier on the

Nemadji River. Upon either the receipt or commitment of funding in the amount of
