Diane and Rob,

I had a conference call with the county code administrators today regarding AB 386/SB 314. They requested two changes:

(1) Change definition of when application is filed (Page 2, lines 15-17) – Currently, the bill indicates that an application is filed when delivered or when it is put in the mail. (The filing date is important because it triggers the 10-day review requirement on line 6 of page 3.) They have concerns about the mailing requirement because they often received applications from Chicago or other areas and it can take 7 days to receive something after it has been mailed. I think they make a good point. What do you think about deleting lines 15-17 and replacing with “the political subdivision receives the application.”

(2) Change 10 days to 10 working days (page 3, line 6) – Because they don’t always open every application on the day that they receive them and sometimes holidays come into play, they recommended changing the “10 days” to “10 working days.” I thought that was a reasonable request, but wanted to get your reaction. (Please do NOT change the “60 days” requirement on page 3, line 3.)
